Councillor G. Moynihan

(a) <u>St. Olan's Place, Aghabullogue – Road into estate in Poor Condition</u>
A O'Brien, EE said he will try and add it to the programme of works as the schedule of works is quite substantial at the moment.

(b) <u>Inchigeelagh Safety Measures</u>

Cllr. Moynihan queried what Clár projects were forwarded from this Municipal District from Cork County Council. J. Molloy, SEO confirmed that the applications submitted by Blarney Macroom Municipal District had not been successful in progressing to the Department of Rural and Community Development but that Cork County Council had decided it would fund 2 projects through its own resources. These included the development of a Playground in Ballinagree and the provision of Vehicle Actuated Signs in Inchigeelagh.

2. CONSIDERATION OF REPORTS AND RECOMMENDATIONS

The Committee noted the correspondence received from M. Manning, Director of Service, Housing which confirmed that Cork County Council does not intend to build social housing on the existing green area at Station Road, Blarney.

The Members noted the Managers Report and associated Appendices.

P. Barrett, SEO outlined the proposals for the Part 8 to the Members.

A lengthy discussion took place among the Members where they all agreed that:

- Social Housing is a priority for Macroom
- Residents are not against the housing but have genuine fears
- Entrance to the Estate dangerous and needs to be addressed before construction
- Construction Traffic Plan needs to be put in place especially for the elderly and people with disabilities.
- P. Barrett, SEO told the Members that there will be specific requirements put in place for the elderly and people with disabilities and will also ensure that the entrance is in place at the start of construction.

A further discussion took place among the Members with regard to reducing the number of houses proposed.

M. Manning, Director of Services, Housing confirmed to Members that they could accept, reject or amend the proposal before them. He stated that should they decide to amend the number of units a Report would be prepared for Full Council on the impact of such an amendment.

5. CHUN NA RUIN SEO LEANAS ÓN GCOMHAIRLEOIR A MHEAS: TO CONSIDER THE FOLLOWING NOTICES OF MOTION

Cllr. Ted Lucey

It is extremely disappointing to learn of the shortfall of approximately $\in 1.5/2M$ for the refurbishment of the Briery Gap. It has now been closed for the past 2 years due to the fire.

It is absolutely essential that the funding shortfall is found. Its closure is a huge loss to local businesses, schools, drama and musical groups from the surrounding areas. As I have highlighted in the past it was the heartbeat of Macroom & the greater Lee Valley area.

Huge praise must be given to the board members who continue to work tirelessly to keep a lot of the events going. It's becoming next to impossible and financially challenging to keep these shows going in the Riverside Park Hotel which is approximately 1.5kms from the town centre.

I therefore request that Cork County Council explores all avenues to address the funding shortfall, to ensure that this fine facility, which encompasses the theatre, cinema and library, is restored for the people of Macroom and the greater Lee Valley area.

Report

Cork County Council understands the importance of the Briery Gap to the whole community of Macroom and the greater Lee Valley. The council is currently examining how the funding short fall can be addressed. This is being done by examining what schemes that various Government Departments are currently running as well as those that they intend to run. Potential sources from European Union programmes are also being examined.

The council is also reviewing the design requirements for the Briery Gap to determine what if any potential cost reduction measures are available.

Jim Molloy, Senior Executive Officer

A discussion took place whereby all Members agreed that they were disappointed with the shortfall of money and queried how the shortfall could be addressed.

J. Molloy, SEO said the insurance money only covered the restoring of the building back to its original condition. However, he said the building needs to be upgraded to meet the Building standards but that the Council were in the process of looking into to the different EU Programmes available.

In response to Cllr. Lucey, J. Molloy, SEO confirmed that the insurance was covering the cost of renting the new library building.

J. Molloy, SEO confirmed that a report would be provided to the Committee each month.

6. VOTES OF CONGRATULATIONS

Cllr. Lucey congratulated the Macroom Girls Under 12 Soccer Team who won the Signalton Super Valu Cup and the Division 1 League.

Cllr. Gobnait Moynihan

Cllr. Moynihan said the centre line of the road over the bridge was in very bad condition.

Cllr. Creed agreed with Cllr. Moynihan and said the footpath was also in very bad condition and was it possible to get the road widened to get a footpath inside the wall.

J. Dwyer, SEE said he had applied to the TII for funding to do the works and was waiting for a response.

In response to Cllr. Moynihan, J. Dwyer, SEE confirmed that the National Primary Budget available to Blarney Macroom Municipal District was €56,000 for 2018. Cllr. Moynihan expressed her disappointment with the lack of funding from TII.

(b) Grass Cutting Contract

J. Dwyer, SEE confirmed that a Contractor had been appointed and the works should be commencing shortly. He said that weed killing works are ongoing around the town.

(c) <u>Inchigeelagh Sewerage Scheme – Information Night</u>
Cllr. Moynihan said that she received an email from Irish Water informing her of an Information Night which was due to be held in Inchigeelagh with only a few days notice and she was disappointed that the notification was sent out so late.

J. Dwyer, SEE said he raised this issue with the TII and was waiting for a response.
