SUSPENSION OF THE HIGH COURT RULING FOR CORK TOURIST OUTLET VILLAGE IN CARRIGTWOHILL

Councillor Michael Hegarty proposed, seconded by Councillor Mary Linehan Foley

During the discussion, the Members made the following points:

- Members said the High Court Ruling was the correct outcome
- They thanked the Chief Executive and Director of Planning
- A debate is needed at Oireachtas level on the matter
- Members said that Cork County Council had regard to planning guidelines in varying the Development Plan
- They said the planning process is robust and interference by the Planning Regulator was unjustified
- Members are formulating a County Development Plan that is correct for the county & region
- The ruling made will have widespread consequences across the Local Authority system
- The decision gives power back to Members to decide what is best for county
- They said the decision was in the best interests of the people of the county
- The ruling has strengthened the power and autonomy of Local Government
- Members stated that regional development is very much a part of council policy
- The ruling has strengthened the power and autonomy of Local Government
- Indicates to Oireachtas what needs to be done legally and said there is a difference between guidelines versus regulations
- It was a serious step as Members decisions were called into question and the ruling has vindicated the actions of the council
- The judge said it was an attempt by OPR to expand the role with no legislature support
- Members spoke about the environmental consequences of the proposed development and stated that 90% of people traveling to the Retail Centre would be travelling by car and that this was not sustainable

- Members said that Kildare Village has been doubled in size
- Said it was more sustainable to have a retail outlet centre in Cork than have people travelling to Kildare from the south of the country
- Members queried the issue of costs and asked what are the implications for joint retail strategy
- Members asked what the implications for the draft Co. Development Plan
- They queried if the OPR has an input on the draft plan and queried if there is an impact on zoning of land
- Said the judgment noted that the Council had passed with flying colours and this says a lot as to how the Council have conducted their business

The Chief Executive thanked Members for their comments. Mr. Lucey said the judgment relates only to Variation no. 2 of the County Development Plan. He indicated a number of issues that are outstanding including costs and said the legal order needs to be made by the court. Mr. Lucey said work continues with the City Council on the Joint Retail Strategy regardless of the outcome of the judicial review. He said a proper approach to zoning and the supporting objectives must be taken.

Mr. Michael Lynch thanked the Chamber and Chief Executive for their guidance. He said the cohesion between political and executive stood the Council in good stead.

Mr. Lucey noted in particular sections 83 to 86 from the High Court Judicial Review judgement made by Judge Humphreys as follows:

"While one can understand the position of the Minister and the OPR, the vast bulk of their argument was dependent on an implicit premise that there was an entitlement to form a view of breach of the requirement for an overall strategy by taking into account that the council had not followed elements contained in non-binding guidelines that the Minister and OPR thought were particularly relevant, and had not explained how the council's action did Not follow such elements of the non-binding guidelines to the satisfaction of the Minister and the OPR. I just don't think that such an analysis sits correctly within the precise and technical terms of the legislative scheme.

Indeed not only that, but the precise way in which the position of the Minister and OPR is now phrased does not sit easily with how the complaint against the council was launched originally as set out in the draft direction formulated by the OPR. The council has a valid point that the complaint has mutated at every hand's turn. No two iterations of the case against it seem to be worded in precisely the same way, and that case continued to evolve right into the hearing.

Ultimately, the practical functioning of local government must draw a clear and workable distinction between matters that local authorities are required to have regard to and matters that are mandatory, and indeed the same applies by analogy in any other area of public law. That echoes the point very clearly made by Collins J. in Spencer Place.

In the case of the dispute between the council and central government here, that line has been blurred by the OPR and Minister, albeit for perhaps understandable policy reasons. Nonetheless, the court cannot allow "have regard to" obligations to be elevated by stealth or in effect, directly or indirectly, into what would amount in practice to mandatory obligations, because to do so would undermine a distinction central to the orderly functioning of the planning code."

He said that he will consider the significant matters that have arisen from the judgement and he will revert to Members once this is done. He said the court was meeting again to consider the further reliefs and it was hoped these would be decided in the Council's favour.
