# 1. Confirmation of Minutes of 25th October 2016 and Matters arising

On the proposal of Ms. Eileen O'Shea and seconded byMs. Ms. Máire Ní Shé the minutes of the West Cork LCDC meeting of 25<sup>th</sup> October 2016 were agreed and adopted by the meeting.

# 2. SICAP Report on Annual Plan 2017

Mr. Andrew Lewis reported that the SICAP sub group of the West Cork LCDC were tasked with the monitoring of the SICAP contract and the review of the SICAP Annual Plan 2017.Mr. Lewis explained that the deadline for the End of Year performance review of 2016 and the full approval of the Annual Plan 2017 would be by the 15<sup>th</sup> February 2017.

The first stage in the process was to approve in principle the proposals from Programme Implementers (Development Companies) contained in their Annual Plans 2017. The Sub Group have met with the Programme Implementers and are satisfied with the Plans for each of the three West Cork Lots. It was also reported that the sub group reviewed the plan based on knowledge gained over the last two years. It was explained that some minor changes were



agreed to performance targets for 2017 and these have been incorporated into the Annual Plans.

The second stage in the process would be the End of Year 2016 performance review, which will be reported to the next LCDC meeting on 26<sup>th</sup> January 2017. Upon approval of the 2016 performance, the LCDC will then be asked to also formally approve in full the Annual Plans for 2017.

The SICAP sub group reported that they were satisfied with the content of the Annual Plans 2017 and recommended that there would be approval in principle for the 2017 West Cork Lots at this stage.

This was proposed by Cllr. Patrick Gerard Murphy and seconded by Ms. Phoebe Bright
