### **3. Community Enhancement Programme 2019**

Ms. K. Keegan advised that the Community Enhancement Programme would shortly be advertised to invite applications for 2019. The 2019 scheme is funded by the Department of Rural & Community Development with support from the Local Community Development Committees (LCDCs) of Cork County Council.

The Countywide allocation under the scheme is €160,000 of which a minimum of 30% of monies has to be applied to projects of €1,000 or less. There are two types of grants available under this Programme:

- Small scale capital grant up to a maximum of €1,000 or less
- Capital grant in excess of €1,000

Those areas moving to the Cork City Council administrative area will apply to the City and the closing date for both City and County Councils was put back to 28<sup>th</sup> June to facilitate the groups who would be affected by the boundary changes.

### **4. Any Other Business**

#### Correspondence from Department of Employment Affairs and Social Protection

Ms. K. Keegan read a letter from the Department of Employment Affairs and Social Protection in response to a letter sent from the LCDCs regarding the eligibility criteria for the Tús scheme. The Department advised that they would monitor the scheme but that there were no plans at the moment to change the eligibility criteria.

The Chair reminded Members that this was the last LCDC meeting during the time of the current Council and wished all involved in the local elections the best of luck.

Ms. K. Keegan on behalf of CCC staff thanked the Chairperson and all members for their work on the LCDC and for their on-going commitment.


#### 5. Date of Next Meeting
