The outgoing Cathaoirleach Cllr. D. Collins also welcomed members to the meeting and congratulated Cllr. Christopher O'Sullivan on his election as County Mayor for 2019-2020. Cllr. Collins thanked the S.E.O., M.D.O. and S.O. for their assistance during his term as Cathaoirleach of the M.D.W.C.

ELECTION OF CATHAOIRLEACH

Cllr. D. Collins invited nominations for the position of Cathaoirleach.

STANDING ORDERS

The M.D.O. circulated the Municipal District of West Cork Standing Orders regulating the proceedings of the Municipal District Members.

On the proposal of Cllr. P.G. Murphy, seconded by Cllr. D. Collins, the Standing Orders were approved temporarily and final approval will be confirmed at the next M.D. meeting.

CONFIRMATION OF MINUTES/MATTERS ARISING

At the proposal of Cllr. C. O'Sullivan, seconded by Cllr. D. Hurley the minutes of the Municipal District of West Cork Meeting held at Áras Beanntraí, on 10th May 2019 were confirmed and then signed by the Cathaoirleach.

ANY OTHER BUSINESS

In reply to a query from Cllr. D. Collins regarding accessibility to Corrin Pier, Goleen, the S.E.O. noted that clarification on Right of Way on same is currently being sought.

Following on from his Notice of Motion at the April 2019 MDWC Meeting requesting Cork County Council to extend the pontoon on Schull Pier to accommodate inshore anglers in the area, Cllr. D. Collins requested a meeting with the Harbour Master and the S.E.O. to discuss same.

Following a query from Cllr. P. G. Murphy regarding road lining requirements in West Cork, Mr. P. Barrett D.O.S. advised members to notify the Area Engineers of areas needing road lining.

Cllr. D. Hurley requested an update on his Notice of Motion of May 2019 regarding the problem of street parking on Castle Street, Dunmanway.

Cllr. P. Hayes requested a meeting between Ballineen Enniskeane Development Association and Cork County Council to discuss projects for Ballineen and Enniskeane including the future of the public convenience in Ballineen.

In reply to a query from Cllr. H. Cairns regarding improvement works required at Turk Head, Church Cross, the S.E.O. noted that the Draft Bye Laws for Piers and Harbours have been approved by the Coastal Management Committee and will shortly go for Public Consultation. The S.E.O. noted that a new engineer has been

appointed to undertake a review of all piers and in conjunction with Harbour Masters will prepare a list of required works on same. Cllr. D. Collins requested works to Zetland Pier in order that it can be re-opened to the public.

Mr. P. Barrett D.O.S. advised members of a procedural difficulty regarding the Part VIII of the Planning and Development Regulations 2001 - 2018 for Castletownbere R-572 Approach Road Realignment, and informed members that the item will be included on a MDWC Meeting Agenda in the near future.

Cllr. P. Hayes queried if Clonakilty Area Office could continue to being responsible for roads projects in the Ring/Barryroe areas following the L.E.A. boundary changes recently implemented. Mr. P. Barrett D.O.S. noted that a number of areas have been affected by the boundary changes and that it would be preferable that Area Offices are aligned with these changes.

Cllr. J. Carroll recommended that members should prepare a submission for the next review of Local Electoral Areas.

The S.E.O. reminded members of the visit of the Canadian Cruize Ship, the Ocean Endeavour, to Bantry Port on 11th June 2019.

This concluded the business of the meeting.
