**Welcome and Introduction**

Cllr. Gerard Murphy welcomed all to the meeting. It was noted that a quorum was in place.

**2. Healthy Ireland Fund – Mr Niall O’Callaghan**

The Meeting agreed to take Agenda item 4-next. Niall O’Callaghan, Healthy Ireland Coordinator, gave an update to the meeting regarding the Healthy Ireland Fund. The projects that were approved under Round 2 are as follows:

Ms. Ger Canning asked that Youthreach would be invited to the TeenTalk events and Ms. Sharon Corcoran supported this proposal. Ms. Canning advised that she would forward a list of where the ETB 7 Meals for 7 Days will take place as it is similar to the Passage West Food Initiative. Ms. Sharon Corcoran advised that the Healthy Ireland program will be guided by a Sub-Group of the LCDC. This Sub-Group is currently active.

### **4. Case Study Presentation by IRD Duhallow**

The Chair welcomed Mr. Jack Roche to the meeting. Mr. Roche gave a detailed presentation to the meeting on the work of the Saoi Network including the Duhallow Community Food Service, Furniture Revamp, Care & Repair & Community Services Information Leaflet.

The Chair thanked Mr. Roche for his presentation and said that the work being done gave good examples of the inter-agency approach being promoted by the LCDCs.

### **5. LECP 2016 to 2018**

Ms. Sharon Corcoran presented a report on the Local Economic & Community Plan. The report outlines the progress made by Cork County Council under the 30 assets as identified in the LECP e.g. Human Capital, Employment/Income. Outside Agencies may need to deliver on some of the actions. The report suggested some potential Lead Agencies & Partners to advance the LECP and further reports will be presented to the LCDC.

The Chair advised that any organisation or community group applying for funding must make reference to the LECP.

### **6. Community Development Initiative**

Ms. Kay Keegan outlined the new capital grant scheme worth €1.5m available to communities and encouraged LCDC Members to promote the Scheme especially to groups who had not applied for grants before now. Ms. Keegan also advised that Local Development Companies are available to help community groups with the application process and that the final grant allocations will be presented to the LCDC for approval.

### **7. Any Other Business**

The Members extended a vote of sympathy to Ms. Marie O'Flynn on the recent death of her father, Mr. Eddie Twomey, RIP.
