Cllr. Buckley

- 1. As a seaside village, we are asking that a traffic report is done please, preferably in the summer months. The lower Camden road was at a standstill yesterday, I had asked for partial yellow lines on the start of the Camden road previously. I would like to see something done on the speed of mounting traffic also on the Camden rd. Even though we are in

Covid19 lockdown, with the amount of day trippers the last 2 days speeding up and down the road you would have assumed that the sports pitches and `Fort Camden were opened.

2. As heavy duty vehicles are using the middle road in Crosshaven more often, and parking is an issue on that road. We would like to see a 'No Heavy Vehicle' access signage installed to stop the bus and heavy laden trucks coming down the middle road.
3. I would like to get an update on the raised table/walkway access to Centra. From the car park as a resident seeing the amount of traffic and kids crossing over to Centra this needs to be addressed ASAP. As Centra has temporarily closed off its 4 parking spots to accommodate access into the shop, cars are parking at the crossing now more than ever.

Cllr. O'Connor

1. That Cork County Council provide an update on the Carrigaline Transportation Plan and the Public Realm Plan and provide the following:
 - Update on the current status of the project.
 - Schematics / Plans for public realm improvements in the Town Centre.
 - Any planned consultation with Carrigaline MD members so members can provide an input.
 - Confirm that Transportation and Public Realm project teams are in consultation and aligned.

Cllr. Lombard

1. I want to welcome the footpath works in the Halfway village. It has connected the village from one end to another. The road widens in the middle of the village and I am asking that the road be line marked including some slow line marking to help define the road.
2. The agreement on the one way system at Hugh Coveney is very welcome and I look forward to seeing the signage and line marking progressing. The long term vision to the one way system was not only the one way system, but also to improve the pedestrian access in the area particularly in front of the businesses. I propose we include this section of footpath in the 2020 footpath program and use bollards in the interim to widen the footpaths.
3. I propose we write to Irish Water and ask them to come to our next district meeting specifically to discuss the Water main replacement in Ballygarvan to the Halfway. There has been 6 breaks to the main since last November each resulting in closing of businesses and the road that goes through the village of Ballinhassig. Irish Water have previously approved funding for this scheme and reneged on delivering the water main. We need a very specific update on the current status of the scheme.

Cllr. D'Alton

1. That Ballygarvan village would be included as one of the recommended locations for installation of vehicle-activated speed signage. Ballygarvan has been identified by the Gardai as being a location that would benefit from such digital speed signage.
2. That updates would be provided on the following ongoing key projects in our Municipal District:
 - a. Carrigaline Transportation and Public Realm Enhancement Plan
 - b. Glenbrook – Carrigaline/Ringaskiddy Greenway

- c. Ringaskiddy Public Realm Enhancement Plan
 - d. Ringaskiddy Village Enhancement Funding for Gobby Beach
3. That Cork County Council would cut the grass verges on the L6518 from Moog to Ringaskiddy National School and on the R613 from Barnahely Cemetery to the junction with the N28.

Cllr. McGrath

1. To seek an update on the provision of a footpath link between the Forest Hill roundabout and Rosehill.
2. That this Committee calls on the Minister for Education to intervene to ensure that Ringaskiddy National School does not have a Teacher removed and to urgently seek confirmation on this matter.
3. To seek a written report from the Environment Directorate in relation to the water outfall on the Crosshaven Road near the bridge on the Carrigaline side of the Greenway car park. Please specify how many complaints have been made in relation to possible pollution over the past 5 years and the outcome of each incident/investigation. Please also specify how this outfall is monitored on an ongoing basis.

1. That feature lighting be considered at Chetwynd Viaduct to show off the historic Cork landmark. Lighting was installed here previously for this purpose, however it hasn't been operating for the past while.
