Cllr Buckley

1. As the road from Brightwater to Drakes Point is now one of the main roads in Crosshaven, efforts need to be made to reduce speeding on the road to protect all road users. Can the engineer look to see what can be done on the road. I would also ask that road markings are repainted as they are currently not visible.
2. After meeting with the CCC wastewater engineer I would like to see money (€25,000) put aside for the suggested detailed report for the Point Road Wastewater works to move to a stage where funding can be applied for. Cleaning up Cork Harbour is a welcomed programme but it is stepping over some important other areas that need to be looked at. The Point Road is one of the most walked areas in the south and wastewater running into the Point Beach needs to be addressed
3. The access road coming into Crosshaven was resurfaced last summer. We now see the new tarmac on the road falling and sloping . Can we get the contractors back please to look at what can be done to rectify this.

Cllr O'Connor

1. That Cork County Council would install a pontoon on the Owenabue Estuary in the Carrigaline Park area to enhance access to the water. It would increase Kayaking, boating and leisure activities in the area of this wonderful amenity.

Currently Kayaks are being launched from the grass river bank. Details as follows:

- Modular Pontoon 4.85m * 1.940m (Supplier: Pontoons Ireland. Tubbercurry, Co. Sligo)
- Unit would float as per tide movements.
- Secured with Chains to river bank piles.
- Ideal for safe launching of Kayaks and will give safer access to small boats.
- Have liaised with a local water activities group "FunkyTown Adventure Centre" who are based in Fountainstown to help define suitable requirements.
- Quote of €6,653 + vat (Supply and install) received.

Cllr McGrath

1. That Cork County Council submit a formal request to TII for a Pedestrian Crossing to be installed at Shanbally Village.
2. That the Engineer assess the stretch of road from Coolmore Cross to the Grotto and consider if additional public lighting could be installed and also to put a plan in place for the construction of a footpath.
3. To request that Seaview estate be considered for inclusion in the 2020 Footpath Programme.

Cllr Dalton O'Sullivan

1. That public lighting is installed at School Road, Ballygarvan
2. That this Municipal District would write to Irish Water as a matter of importance to highlight the urgent need for the Ballinhassig Water Main to be prioritised for replacement in 2020. The impact that regular water outages is having on local residents and rate paying businesses is significant.
