#### 1. Minutes

- Derelict caravans at Garretstown and Garrylucas.
- Ballinacurra road in need of upgrading/repair.
- Road from Ballinamona/Ballyvrin behind Eli-Lilly in need of repair.
- Flooding issue at Ballythomas Bridge.
- Flooding at Rugby Club.
- Lots of potholes on road in Ahiohill area past Kilcolman School.
- Potholes on Knocknacurra to Ballymountain Road.
- Asked that hedge cutting letters be sent out to landowners. CMC asked that the Councillors contact the engineers with details of landowners.
