N. Radley, SEO said this was a unique proposal which could prove to make Macroom a major tourist destination for Cork County going forward.

Mary E. O'Brien, EE gave a detailed presentation to the Members.

- N. Radley, SEO outlined the following key points:
 - More pedestrian orientated
 - Allow for festivals and gatherings
 - Will apply for Town and Village funding if the proposals are put forward and works will be carried out in conjunction with the Briery Gap Project

Cllr. M. Creed

- Looks great
- Loss of 15 car parking spaces big consideration for businesses

Cllr. T. Lucey

 Would support it but parking is a big issue in Macroom – need alternative car parking option

Cllr. M. Looney

- Outstanding plan for Macroom
- Parking space for buses are needed to encourage tourism, especially when the bypass is completed. He said that liners were coming into Bantry – important to get them to come through Macroom

Cllr. E. Lynch

- Good plan modernise Macroom town
- In line with National planning More people focused
- Vital to have alternative parking what alternatives are proposed
- Support Cllr. Looney regarding providing parking spaces for buses

Cllr. G. Moynihan

- Proposal looks really well but not a runner with the loss of parking
- Agree that parking spaces for buses are needed
- Would support if the parking issue was resolved

Cllr. M. Coughlan

- Parking is a big issue
- Agreed that parking spaces for buses were needed
- N. Radley, SEO said it is important to plan ahead before the bypass is completed. She said she understood the Members concerns regarding parking and that they are presently looking at other alternative areas for parking.
- N. Radley, SEO agreed to meet the Members In Committee in the next few weeks regarding proposals for alternative parking.

It was proposed by Cllr. Coughlan and agreed by all the Members to defer their decision until after the In Committee meeting.

 M. O'Leary, MDO said that she has made put it forward as a potential project for consideration under Outdoor Recreation Infrastructure Scheme (ORI)

 M. O'Leary, MDO confirmed that she has received no response to date.

 P. O'Sullivan, EE said that it is proposed to install lights that can change colors as required and that they are presently working on getting them installed.

- (a) <u>Inniscarra Boating Centre No Parking sign</u>
 P. O'Sullivan, EE understands that yellow lines can be installed without byelaws and he will check with the Roads Division in Skibbereen and the local Gardai if it is in order to install yellow lines.
- (b) <u>Farran Wood</u> white lines very dangerous
 J. Dwyer, SEE said it is proposed to refresh the lines at Farran Wood
- (c) <u>Barrahaurin Old Shop Concealed Entrance sign</u> P. O'Sullivan, EE said that he will take a look at it

Councillor Eileen Lynch

- (a) <u>Coachford Footpath</u> pedestrian crossing
 P. O'Sullivan, EE said there was no update.
- (b) Flooding in Coachford camera survey
 P. O'Sullivan, EE said as it is hoped to carry out the survey in the next few weeks when the weather improves.

 P. O'Sullivan, EE said there is no update on funding. He said it hoped that the works will begin in mid-September.

 P. O'Sullivan, EE said the no. of HGVs recorded were higher than normal. The survey was undertaken between the shop and the Terrace. He said 85% of the speed recorded was over 87 km/hour which confirms there is an issue with speed in the area. He said he is planning to carry out further surveys in Millstreet, Cloghboula, Carriganimma and New Tipperary.
- (j) <u>Courtbrack/Killowen Road road not wide enough cars driving into the dykes</u> P. O'Sullivan, EE said he will put tarmac along the edge of the road

• Refurbishments to Macroom Playground – Update

Cllr. Lucey queried what was the Eircode for the playground. M. O'Leary, MDO said she would investigate.

In response to Cllr. Lynch & Cllr. Creed's query regarding funding, N. Radley, SEO said that the funding is hugely welcomed. She said that the Director of Services and the Municipal District will support the majority of the balance needed for the upgrade of the playground. She said it will be put out to tender and funded centrally.

Outdoor Dining

In response to Cllr. Lynch, J. Dwyer, SEE said that the Castle Hotel & T.P. Cotters had applied for a Section 254 license to put out tables and chairs outside their premises. He said 4 no. parking spaces outside the Castle Hotel will be closed off and 3 no. outside T.P. Cotters.

In response to Cllr. Moynihan regarding pedestrian access in front of the Castle Hotel and T.P. Cotters, J. Dwyer, SEE there will be ramps off the footpath onto

the parking spaces and there will be bollards between the pedestrians and the traffic.

Cllr. Moynihan said as regards the canopy being returned to Millstreet, she was of the impression that the works on the monument were going to be completed first. She requested a report on the planned works for the monument for the next meeting. M. O'Leary, MDO said it was agreed to put back the canopy for the summer to facilitate outdoor dining and that the contractor would be ready to start works on the monument in September/October.

Murals

In response to Cllr. Moynihan's query regarding QR codes, M. O'Leary, MDO said that the plaques were nearly ready to go and the QR codes will then be added.

CLÁR Fund 2021

In response to Cllr. Moynihan's query regarding when successful applicants will be notified, M. O'Leary, MDO said there is no specific timeline, it could take 6 weeks or more.

There are three pedestrian crossings in Millstreet Town. These are located on Church Street, Main Street and Coomlogane Street

Church Street/ Sráid na hEaglaise



Tá an crosaire seo suite gar d'acomhal na Cearnóige, le Sráid na hEaglaise agus Sráid Uí Éigeartaigh. Tá na soilse gealánacha rabhaidh go léir ag feidhmiú agus cé go ndearnadh na marcanna bóthair a athnuachan in 2020, caithfear iad a athdhéanamh arís i mbliana.

This crossing is located near the junction of the Square, Church Street and Hegarty Street. All flashing warning lights are operational and although the road markings were refreshed in 2020, they will need to be renewed again this year.

Main Street/ An Phríomhshráid



Tá an crosaire seo suite ar cheann thiar na Cearnóige, in aice le hOifig an Phoist agus Stáisiún na nGardaí. Tá na soilse gealánacha rabhaidh go léir ag feidhmiú, agus rinneadh na marcanna bóthair a athnuachan in 2020. Tá beagán den dromchla ag briseadh suas ar thaobh Oifig an Phoist den chrosaire a bheidh deisithe níos déanaí i mbliana.

This crossing is located on the western end of the Square, adjacent to the Post Office and Garda Station. All flashing warning lights are operational, and the road markings were refreshed in 2020. There is a small bit of surface breaking up on the Post Office side of the crossing which will be repaired later this year.

Main Street/ An Phríomhshráid



Tá an crosaire seo suite ar ar cheann thiar de Shráid Chom Logáin, in aice leis an Séipéal. Tá na soilse gealánacha rabhaidh go léir ag feidhmiú, agus tá na marcanna bóthair i riocht maith. Níl aon obair ag teastáil san áit seo fé láthair

This crossing is located on the western end of Coomlogane Street, adjacent to the Church. All flashing warning lights are operational, and the road markings are in good condition. There is a currently no work required at this location.

Pat O'Sullivan, Executive Engineer / Innealtóir Feidhmiúcháin,

Millstreet Office / Oifig Shráid an Mhuilinn

Cllr. Moynihan welcomed the report and said she was pleased to see so many pedestrian crossings in Millstreet. She enquired if there were plans to install lights overhead.

As regards the Pedestrian Crossing in Church Street, she made the following observations:

- is there adequate signage?
- very little visibility where it is located
- road surface very poor

Cllr. Moynihan queried if there were any plans to upgrade the crossing

P. O'Sullivan, EE responded as follows:

- Will have a look at the signage
- if the pedestrian crossing is relocated, people won't use it.
- there is a lot of work going on nearby but it is planned to include this area as part of the surfacing contract next year

As regards the lights overhead, J. Dwyer, SEE confirmed that there is lighting that can be installed over the pedestrian lights and an application has been made to the NTA to retrofit a no. of pedestrian crossings around the county. J. Dwyer, SEE said he would find out which pedestrian crossings are being retrofitted.

2. Go scaoileann an Comhairle tuairisc faoin tionscadal forgnaíocht cónaithe í Sliabhín Maigh Cromtha.

That the Council would provide an update on its residential construction project on Sleaveen Macroom

Tá an tionscadal seo ag céim na tairisceana fé láthair. Is é an 26ú Bealtaine an spriocdháta le haghaidh tairiscintí le haghaidh Céim 1 -Réamhcháiliú. Tar éis gearrliostú agus tréimhse ré aithrí, táthar ag súil go bhfógrófar Oibreacha Céim 2 ag deireadh mhí an Mheithimh. Táthar ag súil, tar éis iomaíocht rathúil, go mbeidh Comhairle Contae Chorcaí in ann conraitheoir a cheapadh i mí Lúnasa 2021 chun tús a chur le hobair ar an tionscadal seo.

This project is currently at tender stage. The deadline for tenders for Stage 1 Prequalification is 26th May. Following shortlisting and standstill periods, it is anticipated that Stage 2 Works will be advertised end of June. It is expected, following a successful competition, that Cork County Council will be in a position to appoint a Contractor in ugust 2021 to commence work on this project.

Mar nuashonrú agus mar fhreagairt ar rún an Chomhairleora Ní Mhuineacháin maidir le hoibreacha atá le teacht ar an N22 ag Cúil Chomhair, Maigh Chromtha, tabhair fé ndeara gur cuireadh in iúl do Chomhairle Contae Chorcaí go bhfuil Conraitheoirí atá ag gníomhú thar ceann Uisce Éireann (IW) sceidealta chun príomhphíobán uisce fodhromchla a athsholáthar, ag tosnú ag Crois Uí Airtnéada, agus ag dul soir ar lána bóthair den N22 go Corcaigh ag Cúil Chomhair, thar fhad thart ar. 570m. Chuir Uisce Éireann in iúl do Chomhairle Contae Chorcaí go bhfuil sé beartaithe go dtosnóidh na hoibreacha seo ar 01.06.2021 agus go bhfuiltear ag súil go mbeidh siad críochnaithe i mí Lúnasa 2021.

Tar éis an méid thuas a bheith críochnaithe, tá sé beartaithe ag Comhairle Contae Chorcaí conraitheoir a chur chuig an láthair chun forleagan pábhála agus oibreacha feabhsúcháin a dhéanamh

By way of update and in response to Cllr Moynihan's motion regarding upcoming works on the N22 road at Coolcour, Macroom, please note that Cork County Council has been informed that Contractors acting on behalf of Irish Water (IW) are scheduled to replace a subsurface watermain starting at Hartnett's Cross, and working east on the Cork bound lane of the N22 at Coolcour, over a distance of approx. 570m. IW have further advised Cork County Council that these works are scheduled to commence on 01.06.2021 and are expected to be completed in August 2021.

Further to completion of the above, Cork County Council intend to mobilise a Contractor to the location to carry out pavement overlay and improvement works.

Dwyer, SEE confirmed that he was not aware if this process had started yet. Cllr. Moynihan requested that Irish Water are contacted to look for more details. J. Dwyer, SEE he will follow up with Irish Water and T.I.I.
