### 1. DEIMHNIÚ MIONTUAIRISCÍ CONFIRMATION OF MINUTES

On the proposal of Cllr. M. Creed and seconded by Cllr. G. Moynihan the Minutes of the proceedings of the Macroom Municipal District Meeting held on Friday 24<sup>th</sup> July 2020 having been circulated, were confirmed and signed by the Cathaoirleach and the Municipal District Officer.

# 2. NITHE AG ÉIRÍ AS NA MIONTUAIRISCÍ MATTERS ARISING

#### **Councillor Ted Lucey**

- (a) Bridge in Macroom Update
  - J. Dwyer, SEE said they were still waiting on a proposal from Eir. Cllr. Lucey proposed writing to Eir which was agreed by all the Members.
- (b) <u>Briery Gap</u> Update

N. Radley, SEO said that discussions were ongoing and that once an agreement has been reached, it can progress to tender stage.

- (c) <u>Castleview Cross</u> No Update
- (d) <u>Church of Ireland, Macroom</u>
- (e) Bus Stop on the Killarney Road, Macroom
- (f) Bus Depot, Macroom

N Radley, SEO outlined that several proposals were being examined in terms of feasibility but that lack of funding is the main issue. She said that the Chief Executive has established a group to identify and examine options in terms of how Cork County Council could tackle prominent derelict/vacant sites in town centres and has requested details of the number of derelict buildings in all the towns.

Cllr. Creed queried if the funding would come from Cork County Council or Bus Eireann. N. Radley, SEO confirmed that funding would come from both as Bus Eireann would expect that it would be brought back to a more functional use and the Council's plan is that it would benefit the town. She said they are presently looking at different funding streams.

- (g) Project ACT NTA Funding €70,000 Macroom
  - J. Dwyer, SEE said he was putting together a programme of works for the following:
  - Improvement works at Crossing Point Masseytown
  - New Crossing Point at Fitzgerald St. Near Bus Depot
  - Works at Post Office
- (h) Manhole at Castle Street issue ongoing
  - J. Dwyer, SEE he would investigate

#### **Councillor Michael Creed**

- (a) Morrison's Bridge Wall in a very bad state
  - P. O'Sullivan, EE said he met with the contractor and hoped to have a proposal next week. He said carrying out of temporary works could still be complicated and that it would be next year before any work would commence. Cllr. Creed suggested approaching the landowners if carrying out permanent work.
- (b) <u>Litter Bin at Clondrohid Graveyard</u>
  - P. O'Sullivan, EE said works were planned to be carried out the following week.
- (c) Ballyvourney St. Gobnaits by the Church Gulley
  - J. Dwyer, SEE confirmed this has been added to the list of works

#### **Councillor Gobnait Moynihan**

- (a) <u>Irish Water Proposed plans Regarding Waste Water Treatment System Killumney / Ovens</u>
  - M. O'Leary, MDO said she had written to Irish Water and had gotten no reply to date. She said she would send a reminder.
- (b) <u>Pedestrian Crossing at Ovens</u>
  - J. Dwyer, SEE confirmed that the lights are now working and it was planned to install bollards.

#### **Councillor Eileen Lynch**

- (a) <u>Courtbrack Access from Waterloo side</u>
  - P. O'Sullivan, EE confirmed that it is planned to carry out the works the 2<sup>nd</sup> week in October.
- (b) Speed Survey Regional Road from Dripsey to Coachford
  - P. O'Sullivan, EE confirmed that this survey is being carried out at present. He said that there are 3 surveys completed and 2 in the process, which includes this one. Cllr. Moynihan requested details to be forwarded on the average speed.
- (c) <u>Millstreet Can the Disabled Parking space across the road from Reens Pharmacy</u> be moved across the road
  - M. O'Leary, MDO outlined that this possibility will be explored in the context of Age Friendly Programme for Millstreet to installing an age friendly parking space as this can be more widely used by the public. A meeting is due to be held next week on the Age Friendly funding. Cllr. Moynihan said that there are a number of footpaths in Millstreet that are need of repair.

#### **Councillor Michael Looney**

- (a) Matehy School Amber Lights
  Cllr. Looney confirmed that the Principal can fund the light. P. O'Sullivan, EE said that once they submit the cheque to Millstreet we can order the signs.
  There is usually a 6 week lead in time.
- (b) <u>Porters Cross</u> P. O'Sullivan, EE said this was on the Programme of Works

### **Councillor Martin Coughlan**

(a) <u>Spirit of Macroom – Footpath Sinking</u>
J. Dwyer, SEE said he would arrange to carry out works.

## Municipal District Officer Report

Members noted the Report

(a) Project ACT – Activating County Towns – Update

In response to Cllr. Moynihan, M. O'Leary, MDO confirmed that there were 5 picnic benches ordered for Macroom, which includes one disability accessible bench and 1 picnic bench for Millstreet. She said it was planned to decorate each canopy with planters and artificial grass.

Cllr. Lynch suggested putting Cork County Council/Town crest on the canopies to acknowledge Project ACT.

In response to Cllr. Coughlan, M. O'Leary, MDO said she got very positive feedback about the canopies in Millstreet and also about the new mural in the town.

Cllr. Coughlan said he had received some very negative reactions to the canopies in Macroom. N. Radley, SEO outlined that a public consultation process had been done and this was an agreed approach by the local stakeholders i.e. business representatives, tidy towns and community groups. She said due to COVID19 there was a delay in getting the materials to finish the canopies.

Cllr. Creed said he got both positive and negative feedback and that it would take people time to get used to them.

Cllr. Moynihan said they will be very useful, especially for the market on a Tuesday.

Cllr. Looney said he had gotten positive feedback and that they will be a great asset to the town

N. Radley, SEO said that other towns are now looking at Macroom, she said there is also queries coming in from other Local Authorities.

#### (b) 2020 Paint Scheme

M. O'Leary, MDO said there was €13,000 allocated towards the Scheme.

#### (c) Pollinator Plan

Cllr. Moynihan said the Council and the Tidy Towns were carrying out a lot of work and this plan will pull it all together.

### (d) CLÁR

In response to Cllr. Moynihan, N. Radley, SEO outlined that CCC submitted a total of 10 CLÁR applications to DRCD for funding. At present, the unsuccessful applicants are being contacted and being offered an opportunity to meet and discuss their application and are also being given guidance as to what they need to do for any future applications.

# 1. Go scaoileann an Comhairle tuairsc faoin na oibreacha séarchais (Uisce Éireann) í mBáile Mhíc Íre

That this Council would provide an update on the waste water treatment plant works carried out by Irish Water í mBaile Mhic Íre

Is fo-thionscadal é an t-ionad cóireála nua agus na hoibreacha gaolmhara atá san áireamh i mbeartán de cheithre scéim séarachais dar teideal Beartán Meániarthar Chorcaí (Áth an Chóiste, An Druipseach agus Inis Eonáin san áireamh freisin).

Tá na ceithre thionscadal cosúil le chéile go ginearálta agus baineann siad le dearadh agus tógáil Ionad Cóireála Fuíolluisce nua i ngach ceann de na ceithre

shuíomh mar aon le hoibreacha áitiúla eile a bhaineann le séarachas. Tá an próiseas OCÉ (ordú ceannaigh éigeantaigh) / éadála talún críochnaithe do na ceithre shuíomh. Cuireadh tús leis an tógáil i mí Eanáir 2020 agus tógfaidh sé dhá bhliain don bheartán. Chomh maith leis na ceithre shuíomh ionad cóireála tá codanna éagsúla de leagan píopaí agus bainistíocht tráchta ar siúl chun an chuid líonraí den tionscadal a chur i gcrích. Bhí an dul chun cinn tógála ó Eanáir 2020 go maith ach tháinig deireadh leis an obair go léir i ndeireadh mhí an Mhárta 2020 mar gheall ar phaindéim Covid-19, áfach, cuireadh tús arís den chuid is mó leis na hoibreacha ag deireadh mí na Bealtaine 2020.

I gcás Baile Mhic Íre go háirithe, is é seo an ceann is forbartha de na ceithre fhothionscadal agus tá dul chun cinn ana-mhaith ann, in ainneoin gur chuir Covid-19 isteach air, agus táthar ag súil go dtógfaidh an t-ionad cóireála na chéad sreafaí i R1 2021, cé nach mbeidh gach saothar críochnaithe go hiomlán fén am san. Ag an bpointe seo i mBaile Mhic Íre tá an leagan píopaí agus an t-athshlánú bóthair gaolmhar críochnaithe den chuid is mó agus tá dul chun cinn maith déanta sa chomhthéacs seo. Tá obair ar an ionad cóireála ag dul ar aghaidh fé láthair.

The new plant and associated works are a sub-project included in a bundle of four sewerage schemes entitled the Cork Mid-West Bundle (Coachford, Dripsey and Innishannon also included).

The four projects are broadly similar and involve the design and construction of a new WWTP in all four locations along with other localised sewerage related works. The CPO/land acquisition process is complete for all four locations. Construction commenced in January 2020 and will take two years for the bundle. In addition to the four treatment plant sites various sections of pipe laying and traffic management are taking place to complete the networks part of the project. Construction progress since January 2020 was good but all work ceased in late March 2020 due to the Covid-19 pandemic, however, the works were largely recommenced in late May 2020.

In the particular case of Baile Mhic Íre, this is the most advanced of the four subprojects and progress is very good, even taking account of Covid interruption, with the plant expected to take first flows in Q1 2021, although all works will not be quite complete by then. At this stage in Baile Mhic Íre the associated pipelaying and road reinstatement are largely complete and progress has also been good in this context. Works on the plant are currently progressing.

#### Michael Tierney, Senior Executive Officer Water Services

Cllr. Moynihan outlined a number of issues regarding recent road closure in the area and indicated that locals were unhappy with the signage in the area. She also mentioned that the kerbing on the bridge is unsuitable.

Cllr. Creed while acknowledging that there were some problems, complimented the work that was carried out and said that this new treatment plant will be of huge benefit to Ballyvourney.

It was proposed by Cllr. Moynihan and seconded by Cllr. Looney that Cork County Council write to Irish Water to request that the kerbing be removed.

# 3. Íarr ar an Comhairle Contae Chorcaí tuarascáil a chur ar fail maidir leis Árdan Tanyard Wood agus madir leis an Comhairle á thogaint i gceannas

That this Council would furnish a report on Tanyard Wood Estate, Millstreet and the Council taking it in charge

Is eastáit de 125 tigh é Tanyard Wood i Sráid an Mhuilinn. Fuair Carraig Beag Developments cead pleanála faoi 03/6478, 04/4523 & 05/4319. Cuireadh deireadh leis an gcomhlacht sin i 2017 agus ní bhfuarthas aon iarratas an eastát a glacadh ar láimh go dtí gur dhein na áitritheoirí iarratas i Mí na Samhna 2017. Togadh an soilsiú poiblí i gcúram cheana féin.

Chuireadh éileamh ar an banna i 2014 ach ní go dtí le déanaí a fuaireamar an airgead.

Tá fadhb leis an stáisiún caidéalaithe ar an eastáit agus tá an Roinn Pleanála ag obair leis an Roinn Seirbhísí Uisce faoi láthair chun cúrsaí a leigheas. Úsáidfear cuid don airgead ón mbanna don obair seo. De réir John Aherne tá roinnt mion rudaí eile le réiteach chomh maith.

Más eoil dhaoibh ón láithreachas a deineadh ag Development Committee le déanaí tá an Roinn Pleanála ag tosnú ar clár oibre chun mór chuid eastáit a chríochnú chun go bhféadfaí an próiseas glacadh ar láimh a thosnú. Mar a dúirt sa láithreachas deinfear beart d'eastáit atá gar go leor le chéile; níl Tanyard Wood sa chéad beart i gCorcaigh Thuaidh ach beidh sé san áirithe níos déanaí. Ar an gcéad dul síos leigheasfar an fadhb is práinní, sé sin an stáisiún caidéalaithe.

Tanyard Wood, Millstreet is a residential housing estate of 125 houses built on foot of Planning Reg. Nos. 03/6478, 04/4523 & 05/4319 by Carraig Beag Developments, which was dissolved in 2017. The developer did not submit a Taking in Charge application, but a valid Taking in Charge application was submitted by home-owners on 21/11/2017. Public lighting was independently taken in charge by the Council's Public Lighting Section.

The bond provider (AIB) settled a bond claim in recent months having previously indicated that the Receiver would complete the estate.

There are ongoing issues with the Pump Station serving the development and Planning is currently engaging with Water Services with a view to resolving matters using some of the bond monies. John Aherne has indicated that there are a number of other relatively minor issues in the estate that need to be resolved.

As you are aware from the recent presentation made at Development Committee the Estates' Section is commencing a programme of works to utilise funds raised through bond settlements to progress the finishing of estates to a Taking in Charge Standard. Works will be arranged such that a number of proximate estates are grouped together for completion. The first North Cork bundle does not include Tanyard Wood; however, it is intended that it will form part of a later bundle. In the first instance we will attend to the most urgent issue which is resolving the pump station issue.
