MINUTES OF BANDON KINSALE MUNICIPAL DISTRICT MEETING HELD IN TOWN HALL, KINSALE ON 26^{th} July 2019.

This meeting was preceded with a delegation the Municipal Revival Group who made a presentation to the members.

After the delegation left the Council Meeting the Council Members discussed the deputation and the need for an arts/multi-function space within Kinsale town. The meeting identified two different issues:

- 1. The requirement for and the type of arts centre that may be appropriate to Kinsale.
- 2. The location of that arts centre.

The meeting noted that the delegation/group did not have a business plan prepared as had been advised to them at a previous meeting and suggested that a feasibility would have to be prepared addressing these two issues which would inform a business plan for the proposal and suggested that the group make an application from the current LEADER funding scheme to fund a report to address these two issues.

The meeting said "the ability of the group to source funding from LEADER to conduct the feasibility would inform the Council on the group's ability to deliver on the full project".

- Asked about Summercove and whether there was an update?
- Asked for more bins for Kinsale-CMC replied that domestic rubbish was the issue
 and more bins would involve more dumping. MDOH informed the meeting that
 any bin that was being abused would be removed, the meeting identified some
 bins which were being packed with domestic waste.
- Traffic management at Rose Abbey needs to be looked at because of the new houses being built up the road. Kinsale needs a new traffic management plan.
- Toilets in Castlepark for the Dock Beach. EOH stated that currently all suitable property is in private ownership and we were waiting on Insurance Dept to inform us if it is feasible to have portaloos on private property.

Members thanked the volunteers and requested that a full time person be allocated to the Museum. MDOH stated this was the plan in the long term, but that the office accommodation and welfare facilities would have to be upgraded and the future of the museum could only be looked in the context of the facility generating an income.

EOH updated the meeting on Saile and Cllr Murphy commented that Saile was preparing audited accounts and they would be presented at the next Board of Management meeting. Cllr Coleman commended both Cllr Murphy and EOH on their work on the Board for the last year.

Cork County Council have a register of treated knotweed. EOH agreed to get soft copy information on treatment from Environment Dept and will send to Members.

BF the Kinsale Area Engineer updated the members on Kinsale

- The construction of the footpath from Kinsale Manor to Supervalu is going to tender.
- Was written to by Motor Home Ireland and asked for the use of the upper car park at the Fire Station for motor home parking and facilities.
- The Dock beach and Sandycove are upgraded to be included in the water testing schedule.

Cllr. J O'Sullivan

• Asked about the upgrade of the public lights to LED lights in Timoleague. Is there an schedule of which lights and in what order? Can they be turned down if they are too bright?

Cllr. M O'Sullivan

• Can the lining of the Church Road Car Park be looked at? People are parking on the centre of the car park causing problems for others.

Cllr. Murphy

- Asked about when a Traffic Management plan can be started for Kinsale? The Glen needs to be looked at ASAP.
- Pewter Hole Cross- something needs to be done urgently. The junction is very dangerous and there have been a number of crashes recently. CMC replied that funding for non-national roads are very limited.

- Car abandoned in the ditch on the way to Riverstick from the Kinsale side. BF to contact Garda Station.
- Asked about abandoned cars and the process- advised to contact the local council office or Environment Dept.

Cllr. S O 'Donovan

- The LED lights on the Weir are very bright and are shining into people's windows.
- Asked was there a way to stop cyclist cycling over the pedestrian bridge?
- Parking problems in Ardán Estate; can it be lined?
- Asked about the village renewal scheme and the villages chosen for this year-MDOC advised that the funding for this scheme hasn't been yet approved for 2020.

Cllr. Coleman

- The hedges on the footpath in Springmount need to be cut back.
- Bridge in Ballymartle needs to be fixed as it has been damaged.
- Pedestrian Crossing in both Belgooly and Riverstick; can they be covered in the Buff? BF stated it was too expensive.
- Requested that we ask housing the process used to house a new person in Kilbrittain. Asked if someone had a house were they entitled to another house without question?
- Offered the members best wishes to Padraig O'Donoghue on his new post in the City Council and stated that the post in Kinsale needs to be filled ASAP
