MINUTES OF BANDON KINSALE MUNICIPAL DISTRICT MEETING HELD IN TOWN HALL, BANDON ON 19<sup>th</sup> DECEMBER 2019.

The meeting was preceded by a presentation form St. Catherine's Cultural Centre, Kinsale.

#### 1. Minutes

(a) Confirmation of minutes of meeting of Municipal District of Bandon Kinsale held in Kinsale on 28<sup>th</sup> November 2019.

On the proposal of Cllr S. O'Donovan, seconded by Cllr. G. Coughlan the minutes of meeting held in Kinsale on 28th November 2019 were agreed.

## (b) Matters arising

Cllr. Coughlan asked for update on list of issues regarding Kilbrittain. C.M.C said that he was working his way through them.

## 2. Reports & Recommendations.

### 1) Bandon Main Drainage Scheme

Cllr. Coughlan said how traffic management in Bandon is appalling and causing great stress and huge delays. She suggested if more notice was given or if the councillors were informed, they could get the word out. CMC said that the contractors were delayed during unforeseen circumstances. He also said that as Irish Water was the contracting authority, Cork County Council had little authority on this matter. C.M.C. also added that the Gardaí are the traffic authority. Cllr. Coughlan asked that clarification be sought as to completion date.

## 3) Update on Roadworks

Cllr. J O'Sullivan asked if there was an update on realignment of boundaries from West Cork MD. CMC said that as from 1<sup>st</sup> January 2020, Bandon office will be responsible.

## 4) Chairperson's Report.

Cllr. Coleman said that there was no Chairperson meeting this month. He asked about the Town Hall and the group Future Kinsale. MDOH said that the last estimate of works was prepared in 2014 setting out basic works. Now the Architects Department were asked to prepare and updated price based on updated energy requirement and accessibility issues. Cllr. Coleman stressed the need for a plan for Council owned buildings.

## 5) Municipal District Officer's Report.

EOH outlined update on TPREP. MDOH said that a meeting with the contractors will have to be arranged when the contractors are appointed.

EOH said how the launch of Battle of Kinsale maps was postponed until January and that a sign similar to Lusitania Old Head sign was to be placed at Charles Fort.

Cllr. Coleman spoke of an email received by all Councillors and said that items regarding matters raised in email was a matter for the Executive not the members. MDOH said how the museum have undergone substantial works and the plan is to have staff put in place when facilities are in place. Cllr. Coughlan wanted to thank the volunteers for their contribution.

MDOH said how Santa's Outpost in Bandon was a huge success and brought business to the town. EOH said how he had met with LEO's to meet business groups.
