- (a) <u>Briery Gap</u> Update M. O'Leary, MDO said that Members should be sent an update early next week
- (b) <u>Castleview Cross</u> No update

Councillor Eileen Lynch

 - P. O'Sullivan, EE said it is still at the design stage
- (b) <u>Flooding in Coachford</u> camera survey
 - P. O'Sullivan EE said the camera survey has been completed and he is in the process of examining it. He said he has applied for funding of €150,000 under Climate Action Fund for Coachford and as part of that he hopes to replace the storm sewer at the GAA Pitch. He said it is also planned to carry out trial holes in the centre of the village to see what can be done.

In response to Cllr. Lynch regarding the Climate Action Fund, P. O'Sullivan, EE said he applied for it in October of this year and if successful is hoping to be notified early in the new year.

- (d) <u>Courtbrack to Killowen Road Drainage / Road edge repairs any plans to replace the</u> culvert
 - P. O'Sullivan, EE said funding had been sought to replace the culverts, it is hoped to carry out routine maintenance work at the start of the year.

 - P. O'Sullivan, EE said he will have to get a costing from the contractor
- Inniscarra Dam heading east dangerous drop on the right.
 P. O'Sullivan, EE said it is hoped to install a crash barrier under the Low Cost Scheme.

 P. O'Sullivan, EE said he will put this forward for funding for 2022.

(I) Pedestrian Crossing – Masseytown

J. Dwyer, SEE said the lines have been repainted and it is hoped to put in raised crossing under the Low Cost Safety Scheme 2022.

Councillor Gobnait Moynihan

(a) Footpath and Pedestrian Crossing at the GAA Pitch, Coachford

Cllr. Moynihan queried if the footpath going from Dairygold towards the Creche and a pedestrian crossing outside the GAA club were included in the plans that were being drawn up. P. O'Sullivan, EE confirmed that the footpath was but there were no plans to include the pedestrian crossing at this point. In response to Cllr. Moynihan, P. O'Sullivan, EE said it could be included as a separate project under a Low-Cost Scheme but it would not happen until 2023 at the earliest.

(b) Pedestrian Crossing – Church Street, Millstreet

P. O'Sullivan, EE said the lining has been replaced. He said he has spoken with the Public Lighting section in Mallow and they are retrofitting all existing lights and they hope to be on site in January/February next year. He said there will be a public light put directly over the crossing. He said that the surfacing has been included in the 2022 RI Programme - which will include a slightly raised crossing which will make it more visible.

(c) Commemoration Monument Works Millstreet

P. O'Sullivan, EE said it is hoped to commence the works once the Christmas lights are taken down. He said it is hoped to have the works completed by Easter. In response to Cllr Moynihan, he said a contractor has been appointed.

(d) <u>Free Parking in Macroom for Christmas</u>

M. O'Leary, MDO confirmed that there will be 2 hours free parking in Macroom commencing from 1st December to 31st December which will be advertised in the Lee Valley Outlook and also through Cork County Council's Comms Section for social media outlets.

Christmas Lights in Millstreet

Cllrs. Moynihan, Lucey & Lynch complimented everyone for all the work that went in the turning on of the Christmas Lights event in Millstreet on 19th November, 2021 and said it was a great success.

Macroom Christmas Market - 7th December 2021

In response to Cllr. Moynihan, M. O'Leary, MDO said that due to COVID-19 there will be a smaller number of stalls than in previous years. She said that traders and schools who would have attended the Christmas market in previous years and those who expressed an interest were contacted. She said there will be a COVID-19 Compliance Officer on site for the day.

Pay Parking Dividend, Macroom

Cllrs. Creed, Moynihan & Lucey said they was delighted with the allocation for Macroom.

Béal na Bláth Project

As regards the Section 38, Cllr. Moynihan queried if the drawings and particulars of the project were available online and also if submissions could be made online. M. O'Leary, MDO said she will confirm this and let the Members know.

• Carnegie Hall, Millstreet

<u>Signage</u> – Cllr. Moynihan queried if braille was included in the new signage. M. O'Leary, MDO confirmed that it was.

Macroom Playground Refurbishment

Cllr. Lucey queried when the playground would be opened. M. O'Leary, MDO said that once it has passed all the safety inspections, it should be opened this afternoon or Saturday. She said it is hoped that the Co. Mayor would officially open it in the coming weeks.

(d) Part VIII Planning Application for Church of Ireland Building Macroom

M. O'Leary, MDO outlined that it is intended to advertise the Part VIII application in mid December and all plans and drawings will be available will be on public display in Macroom Town Hall when advertised. Due to the Christmas holiday period, the public display period will be extended to 5 weeks with a further 2 weeks to submit observations. She said she will confirm the date of advertisement as soon as she receives it.

Cllr. Lucey welcomed the planned works.

Cllr. Moynihan said she was pleased to see that the Part VIII application was being extended out after Christmas as she said with holidays people may not see it. She queried if the drawings were available online and if submissions can be made online. M. O'Leary MDO said will confirm this and let the Members know.

A speed survey in the village will be carried out early in the New Year

Cllr. Moynihan said that the speed is a big issue in Carriganimna especially as regards the location of the school, she said drivers are at the school before they realise it. She queried if signage would be erected.

Cllr. Creed supported Cllr. Moynihan and agreed that as the school is located on the main road it is very dangerous. He said he welcomed a review being carried out.

Lorgaíodh maoiniú chun Ardán Uí Mhurchú a áireamh i gclár crios mall 2022, leis a bhfuil comharthaíocht nua agus luasteorainn de 30 kph molta.

Funding has been sought to include the Murphy's Terrace in the 2022 slow zone programme, where signage and a new speed limit of 30 kph is proposed.

Cllr. Moynihan said that needs to be looked at as people are driving too fast through the estate. P. O'Sullivan, EE said he is hoping if funding is made available that signage displaying 30km and Children at Play can be erected at both entrances. In response to Cllr. Moynihan, P. O'Sullivan, EE confirmed that only signage is being installed, not speed bumps. Cllr. Moynihan requested that while waiting for the funding if normal Children at Play signs could be installed temporarily. P. O'Sullivan, EE agreed.
