Cllr. Seamus McGrath

1. *To request that the uncontrolled crossing by Forest Park, Upper Kilmoney Road, be upgraded to a Zebra Crossing.*

- 2. This Municipal District calls on Irish Water to immediately and permanently address the ongoing odour issues at the Shanbally Wastewater Treatment Plant.*

- 1. I would ask that the council would look at implementing speed safety measures on the point road before the Crosshaven Boatyard entrance. With the new owners using access onto the road with large vehicles and machines, the volume of traffic and the many walkers on the point road has increased.*
- 2. I would like to see Carrigaline MD in the future, plan to have areas/verges cut back before school starts back in September. Children's access to schools from laneways/footpaths should be free of verges/brush and if need be laneways cleaned down for safe passage for school going children.*
- 3. I would like an update please on the proposed safe passage walk/route from Fountainstown to the Minane Bridge access road.*

Cllr. Ben Dalton O'Sullivan

- 1. That the Footpaths at Fernlea, Carrigaline would be included in the next footpath replacement program.*
- 2. That a footpath would be constructed from the GAA field in Waterfall, to the existing footpath in the village. I note that there is a considerable distance from the GAA field to the village, I would request that the Local Roads Design Office would look at this as a part of an NTA fund or an appropriate funding scheme.*
- 3. That a gully would be installed on the R613 at the gate of the Marian Hall, Ballinhassig.*
