1. *"I have received a request from some residents in Roberts Cove regarding an update with the water system for the area. The swimmers were looking for a new public shower and the water tap to be reinstated. It is my understanding that Cork County Council is still delivering water weekly to the area. This is unsustainable and residents would like an update please on when this issue will be rectified"*
