Planning and Development Regulations, 2001 Section 183 - Notices

In accordance with the provision of Section 183 of the Local Government Act 2001, the disposal of the property as shown hereunder shall be carried out in accordance with the terms specified in the notices circulated to members.

(a) Church Road, Durrus, Co. Cork

Disposal of land at Church Road, Durrus, Co. Cork, area of land measuring c.0.0099 hectares / 99m2 acres as per the attached map, in Cork County Council ownership since 2000. Proposed to dispose to Donna Cleary.



(b) Ardmanagh, Schull, Co. Cork

Disposal of land at Ardmanagh, Schull, Co. Cork, area of land measuring c.0.028 hectares / 0.056 acres as per the attached map, in Cork County Council ownership since 1997, proposed to dispose to John and Noreen Seward.

(c) Carrig Rossa, Rossmore, Co. Cork

Grant of a Wayleave at Carrig Rossa, Rossmore, Co. Cork, to facilitate Council housing Scheme, area of 54m x 10m average width, proposed to dispose to Uisce Eireann.

(d) Knockeenbwee, Drimoleague, Co. Cork

Grant of Right-of-Way at Knockeenbwee, Drimoleague, Co Cork, area 18m x 5m wide, acquired from records not available, registered to CCC since 1972, proposed to dispose Anthony & Eleanor Daly.

(e) Speed Limit Amendment - Gallanes, Clonakilty

Proposed reduction in existing speed limit on R600 Gallanes, from 60 kph to 50kph.

3. NOTICES OF MOTION/ FOGRA RUN

(a) Clir Karen Coakley

"I am calling on Cork County Council to: examine the feasibility and advantages of employing a Manager to run the Town Hall in Skibbereen".

(b) Cllr Declan Hurley

"That Cork County Council request a face to face meeting with representatives of Uisce Éireann to discuss the on-going issues with the Waste Water Treatment Plant in Dunmanway, which has stalled and is preventing any development in the town for the foreseeable future."

(c) Cllr Ross O' Connell

"That this council would make it a priority to raise a short stretch of the road at Ballyrisode between Kealfadda Bridge and Hungerford Woods to prevent the main Schull to Goleen road (R591) from becoming impassible during future intense rainfall events. Furthermore, that the criteria for activating the existing flood warning sign on the approach to this frequently flooded area be looked at, as the warning lights failed to activate during the last flooding event."

"I am calling on Cork County Council for support with concerns regarding public safety and environmental protection at Kilkileen Beach in Lisheen. Signage of safety measures, in relation to speed on the road and litter on the beach, to ensure the safety and well being of local beach users and the preservation of the natural surroundings.

(e) Cllr Danny Collins

"Following my previous motion I am calling on the Council to confirm the proposal on a new layout for Bantry town centre and to clarify if we have contracted anyone for a proposed design. It is imperative we work on this now as the proposed culvert works are supposedly starting next year."

(f) Cllr Danny Collins

"I am calling on the Council write to Kerry County Council so we can work together on a letter to be sent to the T.I.I. to install some led lighting along the Caha Pass Tunnel that separates Co. Cork and Co. Kerry."

(g) Cllr Danny Collins

"I am calling on the Council to confirm when a full time Engineer for the Schull Council Area office will be appointed."

(h) Cllr Paul Hayes

"That Cork County Council would apply for the Community Monuments Fund on behalf of the medieval church at Rathbarry. This grant, which would cover 100% of the preservation costs, would ensure that the necessary work would be carried out at the earliest possible time, without any cost to the Council."

"That this Council would again examine the possibility of providing a footpath from Clonakilty to Ring village, and would also upgrade and clear the vegetation on the existing stretch of footpath along the coast road from Faxbridge towards Ring."
