- Said those questions were seeking clarity on the negotiation of amendments to a piece of international law that Ireland will be obliged to follow
- The response from the minister's office has referred to only one of those 6 questions, question 4
- Said the response answers question 4 in relation to the Pandemic Treaty but the motion refers to the amendments to the international health regulations

Members agreed to write back to the Minister for Health to ask that the Minister address questions 1, 2, 3, 5 and 6 of the motion. Members also agreed to ask that the Minister would answer question 4 in the context of the amendments to the international health regulations and not in the context of the Pandemic Treaty.

#### MINISTER OF STATE FOR FINANCIAL SERVICES, CREDIT UNIONS & INSURANCE

Correspondence received 08/12/2023 from the Minister of State for Financial Services, Credit Unions and Insurance in response to the Council's letter dated 24/10/23 in relation to the accountability of insurance companies to homes and businesses damaged by flooding during Storm Babet.

### During this discussion, the Members made the following points:

- Said the response does not address the issues raised
- Said they are seeking representations and positive progress from Minister Carroll MacNeill in relation to homes, businesses and community hubs that have now lost flood insurance following Storm Babet
- Said they are asking the government to assist those who now have no flood insurance by indemnifying their policies or ensuring Insurance Companies work with those affected
- Said a policy must be in place until the flood relief schemes are installed in the particular East Cork Areas affected by the loss of flood cover.

Members agreed to write to Minister Caroll MacNeill to seek representations and positive progress in relation to homes, businesses and community hubs that have now lost flood insurance following Storm Babet. Members also ask for the detailed information of the outcome of the Ministers meeting with the Insurance Companies in November 2023 and December 2023, in particular in relation to East Cork.

## OLDIES & IRISH PROGRAMME 96FM

## Cllr. Ann Marie Ahern proposed, seconded by Mayor Frank O'Flynn

Members said the decision to reduce the Oldies & Irish slot on 96fm is a retrograde step and the programme should be reinstated to its four hour slot.
