## **2)Notice of Motion Cllr G.Coughlan**

- ‘That Bandon Kinsale MD would undertake a review of parking facilities in Courtmacsherry and consider the installation of EV chargers to facilitate local people and holiday makers.’
- ZEVI ( Zero Emission Vehicles Ireland) to prepare a strategy of the rollout of same  
parking realignment on the pier last year  
We will be asking that any boats parked in bays as this is easting into spaces
- ‘That Bandon Kinsale MD would implement a one-way traffic system at The Rock, Kinsale, with traffic travelling up The Rock and down to the town via Barrack Street. This to facilitate the construction of a footpath to ensure the safety of pedestrians. ‘
- That Bandon Kinsale MD will invite representatives from Irish Water to discuss current operations and future plans for managing the water distribution and management from the River Bandon with members.  
Further, in the course of such a meeting, I propose that BKMD would call for two new reservoirs on the Bandon River , one on the south side of Bandon town and one for Innishannon Water treatment plant which could be used to supply Bandon instead of pumping water from Inniscarra.  
Further, that the River Lee would in future supply the entirety of the population of Carrigaline, replacing the current situation where half of Carrigaline is supplied from the Bandon River. These measures to be put in place to secure water supply in to the future for the rapidly growing populations of Bandon and Kinsale along with the hospitals, schools and businesses in the area in to the future.
