### Section 1(a): Introduction

#### **Overview of this Report**

The purpose of this report is to summarise the views and recommendations of all those who made submissions during the public consultation on the draft Ministerial Direction and make recommendations in relation to the best manner in which to give effect to the draft direction.

The **Chief Executive's Report- "Draft Direction, Summaries, and Recommendations"** consists of the following:

#### **Public Consultation**

The public consultation stage on the Draft Ministerial Direction on the Cork County Development Plan 2014 took place from Wednesday 14<sup>th</sup> January 2015 to Wednesday 28<sup>th</sup> January 2015 at 4pm.

These public consultations were advertised through a number of media:

- An advertisement was placed in a number of Newspapers circulating locally;
- ➤ A notice was placed on the Cork County Council website;
- Prescribed authorities were notified;

A copy of the draft direction was available for inspection each working day, exclusive of public holidays, between the hours of **9.00 a.m. and 4.00 p.m. at the following locations**:

- 1. Planning Department, Floor 1, County Hall, Cork.
- 2. Planning Department, Norton House, Skibbereen, Co. Cork.
- 3. Cork County Council Divisional Office, Annabella, Mallow.
- 4. County Library and Branch Libraries during normal library opening hours-





#### 5. Online at www.corkcoco.ie at all times.

In order to aid the public in accessing information and making a submission on the Draft Ministerial Direction on the Cork County Development Plan 2014 Cork County Council made an electronic copy available on the Cork County Development Plan 2014 webpage. The public notice and the draft ministerial direction were available to download. Submissions were invited from the public during the consultation period and could be made electronically (via the Co Council's Web-site/Cork County Development Plan web page) or sent via post.

A total of 15 submissions were received. A list of the persons and organisations that made submissions is included in Appendix A. One late submission was received after the public consultation period had ended and therefore was not taken into consideration in preparing this report.

#### Legal Background to the Chief Executive's Report

Section 31(8) of the Planning and Development Acts, as amended, requires that the Chief Executive no later than 4 weeks after the expiry of the public consultation period shall prepare a report on any submissions or observations received under subsection during that period which shall be furnished to the Minister and the elected members of the planning authority.

Section 31(9) states that the report referred to in subsection (8) shall—

- (a) Summarise the views of any person who made submissions or observations to the planning authority,
- (b) Summarise the views of and recommendations (if any) made by the elected members of the planning authority,
- (c) Summarise the views of and recommendations (if any) made by the regional assembly,
- (*d*) Make recommendations in relation to the best manner in which to give effect to the draft direction.

Section 31(10) states that the elected members of the planning authority may make a submission to the Minister in relation to the notice issued by him at any time up to the expiry of the period of time for public consultation.

Under the provisions of Section 31(8) of the Planning and Development Act, 2000, as amended, the Section 31(8) Chief Executive's Report shall be furnished to the Minister and the elected members of Cork County Council not later than <u>Wednesday 25<sup>th</sup> February 2015</u>.

Section 31(9)(d) states that report should "make recommendations in relation to the best manner in which to give effect to the draft direction"

Under Section 31(11)(a) the Minister will consider the report furnished under Section 31(8) and any submissions received under section31(10) where he believes that no material amendment to the draft direction is required, or that further investigation is not necessary in order to clarify any aspect of the report or submissions, he may decide ,no later than 3 weeks after date of receipt of the report (Wednesday 18<sup>th</sup> March 2015) for stated reasons to issue the direction with or without minor amendments or not to issue the direction.

Under Section 31(17) the direction issued by the Minister is deemed to have immediate effect and its terms are considered to be incorporated into the plan, or, if appropriate, to constitute the plan. No variation of the County Development Plan will be required.

Draft Direction does not acknowledge the constitutionally protected role of local government under Art. 28A of Bunreacht na hEireann. 7. Submits that the Minister has not shown that he has any proper legal basis for making the proposed Section 31 direction. 8. Appropriate course for the Council is to maintain the integrity of its decision in relation to the making of the current CDP.

CDP2014S_3115/2025	D'Alton, Cllr. Marcia	1. Contravenes both Article 7 of the Aarhus Convention and Articles 11 and 12 of the 2000 Planning Acts.  2. Plan is not in contravention of national waste policy. Purpose of Objective ZU 3-7 is not to restrict any kind of waste management type but to advise on where it should be sited. Plan supports national waste policy and identifies broad county level policies for guidance on siting waste management facilities. Plan does not prohibit energy recovery through incineration. The suggestion that ZU 3-7 as drafted runs counter to government policy indicates that the many other constructive references in the Plan to waste to energy were not considered.  3. Draft Direction is in contravention of national waste policy. There are many technologies capable of being considered as large scale waste treatment facilities. Current ZU 3-7(c) Indicates that all large scale waste management facilities may be considered within Strategic Employment Areas. Minister whilst advising against determining in favour of one process over another then proceeds to request amendment which in effect does exactly that, contravening his own instructions. The amendment would favourably single out incineration with energy recovery over so many other technologies further up the waste hierarchy. Direction is anti-competitive and unsustainable.  4. The public consultation procedure associated with Section 31 draft Direction is in contravention of Aarhus Convention. If Minister is intent on amending the CDP what is the purpose of public consultation other than to give lip service to a legislative requirement. At a minimum public participation requires effective notice, adequate information, proper procedures and appropriate taking account of the outcome of public participation, this processes fails on all these counts. Minister has made it quite clear that the opinion of the public is irrelevant in this case.  5. Requests that the Chief Executive reflects on author's rejection of the draft Direction and Ministers failure to consider the CDP 2014 in
