LOCAL IMPROVEMENT SCHEMES - TERMS AND CONDITIONS

Please note that the making of an Application under the Local Improvement Scheme and its acceptance / approval by the Local Authority constitutes an Agreement between the Applicants / Beneficiaries and the Local Authority for the purposes of Section 81(4)(a) of the Local Government Act 2001

1. Eligible Roads

Subject to the terms and conditions of the Local Improvement Scheme, a Road Authority may provide assistance by way of the carrying out of work involving the construction or improvement of an eligible non-public road.

An eligible non-public road is a road to which the following applies:

(a) The road provides access to parcels of lands¹, of which, two or more are owned or occupied by different persons, **one of which must be used for agricultural/harvesting purposes.**

2. Amenity Roads

In addition, works can also be carried out on **Amenity Roads**. Amenity Roads are non-public roads leading to important community amenities such as graveyards, beaches, piers, mountain access points or other tourist / heritage sites. If there are other beneficiaries on the road, Cork County Council may, at its discretion, seek a portion of the local contribution from the other beneficiaries, subject to a cap of €1,200 per beneficiary.

- 3. Applicants with agricultural holdings must provide current documentation to verify that they are engaged in agricultural activities on the parcel of land accessed by the road project i.e. a herd/flock number and a copy of the maps associated with their Basic Payment Income Support for Sustainability Scheme provided by the Department of Agriculture, Food and the Marine or equivalent documentation. These documents must be dated within the last 12 months.
- **4.** Where the occupier of the land is not the registered owner, the occupier must provide a copy of the Lease Agreement in place for the land in question, together with confirmation of the consent of the registered owner (or beneficial owner in the event that the registered owner is deceased).
- **5.** All Applicants / Beneficiaries to the Scheme must complete and sign the prescribed Form No. 14 (b) attached to the Application Form giving details of their holdings.

¹ "Parcel of land: is any owned or occupied land that is accessed by the road and that may be used for agricultural purposes. It is recommended that the parcel is <u>at least 1 hectare in size</u>."

6. Types of Works

Local Improvement Scheme funding may be used for the construction, improvement or reconstruction of roads or bridges. The works must be of an essential and a more substantial nature, such as strengthening weak sections, rut filling, resurfacing and opening water channels. Existing fences may be removed, or set back and new fences provided, where necessary and feasible at reasonable cost and as part of the road project.

7. Non-Eligible Works

The following works are not eligible for grant assistance under the Scheme:

- The provision of new fencing or the replacement of existing fencing on their own, **or**
- Drainage works on their own, ordinary maintenance, or other minor works, which applicants could do themselves.
- **8.** Applications will be assessed and costed by Cork County Council and prioritised in accordance with the terms of the Scheme. The estimated cost of the work (Cost of Labour, Materials and Equipment), is determined by the Council's Area Engineer and includes VAT. An Administration fee of 10% is also included in the overall cost of the project.
- **9.** The total local contribution must be paid in full to Cork County Council, before the local authority undertakes the approved works on the scheme, subject to Grant funding being available to the Council.
- **10.** The proportion of Local Contribution is as follows:
 - a) 10% of the estimated cost of the project (inclusive of VAT and administration fee) for eligible roads with up to and including 5 beneficiaries,
 - **b) 15%** of the estimated cost of the project (inclusive of VAT and administration fee) for eligible roads with **6 or more beneficiaries**.
 - c) The maximum amount of contribution payable by any beneficiary is capped at €1,200, provided that all beneficiaries are contributing to the cost of the works. Where all beneficiaries are not willing to contribute, the voluntary contribution will still be calculated on the basis that all of the beneficiaries are contributing, as outlined in the following example:

- d) Cork County Council will pay the local contribution of 15% in relation to an Amenity Road. However, if there are other beneficiaries on an Amenity Road, Cork County Council may, at its discretion, seek a portion of the local contribution from the other beneficiaries, subject to a cap of €1,200 per beneficiary.
- **11.** The Applicants / Beneficiaries must decide amongst themselves how to organise their respective portions of the Local Contribution.
- **12.** The total of the local contributions must be paid as a single sum to the Local Authority <u>before</u> the work begins.
- **13.** Contributions in kind (e.g. free labour or materials) will not be accepted in lieu of cash.
- **14.** The Council may decide not to proceed with the Scheme if:
 - a) The acceptance of the grant offer and the local contribution is not promptly made within the requested time limit, **or**
 - b) The Council has no matching grant funding to proceed.
- **15.** The Applicants / Beneficiaries must arrange amongst themselves to provide to Cork County Council, without cost, any lands which may be required for the construction or widening of any roadway or drain.
- **16.** Cork County Council will arrange to carry out the work.
- 17. All beneficiaries by signing the prescribed form 14(b) must give their full consent to the carrying out of the works, including where required, entry by the Local Authority or its agents to their lands.
 All other property / landowners (non-beneficiaries) whose lands or interests may be affected by the proposed work must give their written consent to the carrying out of the work including where required, entry by the Local Authority or its agents to their lands.
- 18. Cork County Council at its discretion will decide on the specification of the work and on the best manner of carrying it out. The Applicants / Beneficiaries shall not have any claim against Cork County Council for any imperfection which may exist in the finished work, nor for any failure by the Council to complete the full amount of the approved works.
- 19. Cork County Council shall not have any liability for maintenance of work carried out. The Applicants / Beneficiaries are required, when the Project is completed, to thereafter maintain the work in good order and repair at their own charge and expense, and that the carrying out of any further works will not involve any liability on the part of the Local Authority for subsequent maintenance.

- **20.** There is no obligation on Cork County Council to take in charge a road on which works have been carried out under the Local Improvement Scheme.
- **21.** The funding under this Local Improvement Scheme is being provided by the Department of Rural and Community Development and is subject to compliance with the terms and conditions of the Scheme.
