# **Uisce Éireann**

Correspondence received 08/05/2024 from Uisce Éireann in response to the Council's letter dated 12/04/2024 regarding the Carrig Na bhFear wastewater treatment plant.

Members made the following points:

- They were utterly disappointed with the response received.
- Towns & Villages are being held at ransom by Uisce Éireann.
- How do we ensure that this does not continue.
- Uisce Éireann are ducking and diving.
- Other areas on the list should have been completed by now.
- The first seven on the list have been approved since 2019.
- Things are developing at a snail's pace.
- The situation in Crossbarry is also ridiculous.
- Decisions taken by Uisce Éireann do not make sense.

• Uisce Éireann should be abolished as it is not working.

Chief Executive, Valerie O'Sullivan made the following points:

- It is great to hear the members are as frustrated as the executive.
- Cork County Council put forward a list of 35 areas.
- 7 were focused on in 2019 and nothing has progressed since.
- Cork County Council granted 8,000 permissions only 3,000 were completed.
- There is a massive shortfall of water infrastructure.
- There is sufficient land zoned to absorb increase of housing.
- Crossbarry is 100% an Uisce Éireann issue.
- Uisce Éireann is not agile when it comes to change.
- Cork County Council wholeheartedly reject the stance set out by Uisce Éireann.

Members agreed to write to the Minister and seek clarity on the response received and to outline the frustrations of members.
