ORDÚ LUASTEORANN OIBREACHA BÓTHAIR/ ROADWORKS SPEED LIMIT ORDER

Section 10 of the Road Traffic Act 2004, as amended by Section 55 of the Road Traffic and Roads Act 2023.

Notice is hereby given, pursuant to Section 10 (1) of the Road Traffic Act 2004, as amended, BY Section 55 of the Roads Traffic & Roads Act 2023, that a Road Works Speed Limit Order has been made in the interests of road safety and to facilitate the installation of ducting and joint bay chambers associated with the Celtic Interconnector Project.

Location:

Install a 60 km/h Special Speed Limit at Road Works on the N25, a reduction of the existing 100km/h speed limit, for approx. 4km, from the start point of the existing speed limit signs to the eastern side of Castlemartyr and extend to the speed limit sign on the western side of Killeagh between the co-ordinates 197129, 73687 and 200174, 75862.

Existing Speed Limits through the villages of Castlemartyr and Killeagh will remain unaffected.

The Road Works Speed Limit to be applied shall be 60km/h (reduced from 100 km/h)

This speed limit applies from midnight on Monday 21st October, 2024 to midnight on Friday 20th December, 2024 or such earlier date as determined by Cork County Council.

Relevant speed limit signs will be in place.

Tugtar fógra leis seo, de bhun Alt 10 (1) d'Acht na mBóithre 2004, arna leasú, AG Alt 55 den Acht um Thrácht ar Bhóithre agus Bóithre 2023, go ndearnadh Ordú Luasteorann Oibreacha Bóthair ar mhaithe le sábháilteacht ar bhóithre agus chun suiteáil duchtála agus cuasán bá siúntála a bhaineann leis an Tionscadal Idirnascaire Ceilteach a éascú.

Áit:

Cuir Luasteorainn Speisialta 60 km/h i bhfeidhm ag na hOibreacha Bóthair ar an N25, laghdú ar an luasteorainn 100km/h atá ann cheana, ar feadh thart ar 4km, ó thúsphointe na gcomharthaí luasteorann atá ann cheana féin ar an taobh thoir de Bhaile na Martra agus leathnaigh chomh fada leis an gcomhartha luasteorann ar an taobh thiar de Chill Ia idir na comhordanáidí 197129, 73687 agus 200174, 75862.

Ní bheidh tionchar ar na Luasteorainneacha atá ann cheana trí shráidbhaile Bhaile na Martra agus sráidbhaile Chill Ia.

Is é an t-Ordú Luasteorann Oibreacha Bóthair atá le cur i bhfeidhm ná 60km/h (laghdú ó 100 km/h)

Beidh an luasteorainn seo i bhfeidhm ó mheán oíche Dé Luain, an 21 Deireadh Fómhair, 2024 go dtí meán oíche Dé hAoine, an 20 Nollaig, 2024 nó cibé dáta níos luaithe ná sin de réir mar a chinneann Comhairle Contae Chorcaí.

Beidh comharthaí luasteorann ábhartha i bhfeidhm.
