Hours of opening	11:00am to 3:00pm Sunday 24 th November only.
Regulations:	All current and future law, regulations, notices or any order of any applicable governing body which affect the Organiser, the Exhibitors, the Chalet, the Permitted Purpose. Please note that stallholders will not have individual access to electricity.
Criteria for Application	Stall holders will be selected at the Organiser's discretion against a strict criteria including the range of products available at the market, quality of product, uniqueness and customer appeal. We do not offer exclusivity on any products.
Location	Stall holders will have their stall position allocated on the day of event by the stewards on site.
Opening Hours	The Christmas market will be open from 11:00am – 3:00pm. All stalls must be manned during trading hours.
Set up and dismantling	Traders will be able to set up on Sunday from 9:00am-10:30am. All stalls must be cleared by 7:00pm. There will be no access by vehicles after 10:30am or prior to 3:00pm.
Rubbish	Rubbish Disposal is the responsibility of the Stallholders, who must dispose of their rubbish in the appropriate manner.
Insurance	Traders must hold their own Public Liability Insurance with minimum cover of €6.5 million and €13 million employers liability
Stall Appearance	Traders are requested to decorate the exterior of their stall with a festival garland and/or battery-operated Christmas lights
