1. Part 1 News & Updates

1.1. Climate Action

1.1.1 Community Climate Action Programme (CCAP)

A portfolio of thirty-one (31) projects totalling €1,000,265.28. was submitted to Department of Environment Climate & Communications (DECC) for approval in May and was fully approved by DECC on the 9th of July last.

Grant agreements in place with 29 of 31 projects, all of which formally commenced on **15th August 2024**. 2 projects are awaiting final permissions, which we hope will be obtained in the next couple of weeks. All projects must be completed in 18 months.

Breakdown of the current project allocation is as follows:

Projects approved for funding under Call 1 of the CCAP focus on all five programme themes (Community Energy, Travel, Food and Waste, Shopping and Recycling and Local Climate and Environmental Action). These include projects focusing on energy upgrades (deep retrofit and insulation, installation of solar PV), active travel supports (cycling routes and infrastructure), community gardens, recycling initiatives, water filling stations and local planting.

There are 6 of these projects from the West Division, with approval for €120,023.61 in funding. Projects approved for funding in the West Division included those involving:

- the installation of a water-filling station to promote reuse and a reduction in single-use plastics,
- the upgrade of community-operated recycling centre with glass crusher to promote reuse of materials,
- solar PV installation on community buildings and sporting premises,
- the installation of community biodigester to address food waste and the provision of a pilot food waste collection scheme,
- the development of a community garden, and
- the deep energy retrofit of an existing community owned leisure centre.

CCC proactively engaged with DECC regarding the surplus of €240,734.72 from the first allocation of funding and have submitted a request to DECC to run a short supplementary call in December 2024. This proposal was approved by DECC on 26th September 2024, and it is planned that the supplementary call (CCAP Call 1, Part B) will open for applications in December 2024, for a period of six weeks (Dates TBC). Further details regarding eligibility and programme target themes TBC.

1.2. Air Quality

1.2.1 EPA calls for strong application of Solid Fuel Regulations.


In their recently published <u>Air Quality in Ireland Report 2023</u>, the Environmental Protection Agency (EPA) has called on Local authorities to facilitate proactive choices on both home heating and travel, through strong application of the Solid Fuel Regulations and supporting alternatives to car travel.


The report again highlights that air pollution can be a major environmental risk to people's health, with approximately 1,600 premature deaths annually in Ireland due to poor air quality.

Ireland's latest monitoring shows we are in compliance with current EU standards, and Air Quality in Ireland is generally moving in a positive direction. However, Ireland has committed under the national Clean Air Strategy to achieving the more stringent World Health Organisation (WHO) guideline values by 2040 which will be a challenge.

The main pollutants of concern are fine particulate matter (PM2.5) from solid fuel combustion and nitrogen dioxide (NO2) from vehicle emissions/traffic.

1.3. Waste

1.3.1 Phasing out of the Levy Exemptions for Construction and Demolition Waste.

The phasing out of the waste recovery and landfill levy exemptions for construction and demolition waste came into effect on 1st September 2024. The changes will reduce construction waste and encourage the construction industry to use by product (Article 27) classification as an alternative. The introduction of the levy will reduce construction industry costs and help Ireland achieve its overall waste performance and EU targets. There are four phases commencing on 1st September 2024 for recovering the Waste Recovery levy. The phased approach gives the construction industry time to engage with the Article 27 self-declaration process and ensuring materials are recycled and reused for longer

1.4. Water Quality Programme.


1.4.1 Water Action Plan 2024: Ireland's third River Basin Management Plan launched.

On the 4th September last the **Water Action Plan 2024** was launched. The plan which is Ireland's 3rd River Basin Management Plan covering the period 2023 – 2027, sets out a roadmap to restore Ireland's waterbodies to 'good' status or better, and protect against further deterioration, through an integrated catchment management approach.

Key actions in the Plan include tighter controls on the use of fertilisers that impact water quality, a greater focus on compliance and enforcement with over 60 new staff at local level, and a target of 4,500 farm inspections nationally per year. In addition, continued investment in wastewater infrastructure will see Uisce Éireann investing a multi-billion Euro budget over the period 2025-2029 to reduce impacts on water quality, a new national River Barriers Mitigation Programme will ramp up efforts to remove river-blocks that impact on species like salmon and lamprey swimming upstream to spawn, and a review of arterial drainage requirements and the underpinning Arterial Drainage Act will be undertaken in the context of land use.

The Plan aims to see an additional 300 waterbodies achieve 'good' status by 2027, with targeted measures to improve over 500 more. A Community Water Development Fund is to be provided for 2025, which will provide financial supports to local projects and initiatives.




1.4.3 EPA Water Quality Report

In July The EPA published its annual report on Drinking Water Quality in Private Group Schemes and Small Private Supplies – 2023


- All private suppliers *should* register with their local authority so their supplies can be monitored annually.
- All registered supplies *must* be monitored by local authorities annually to protect public health.



22% of the SPS on EPA register are in Co. Cork

KEY FINDINGS IN 2023 Report:

- Only 1,665 Small Private Supplies (SPS) are registered with local authorities across the country. Consumers may not be aware that they could be drinking water from an unmonitored supply, potentially putting their health at risk.
- •1 in 20 small private supplies and private group schemes failing to meet *E. coli* standards in 2023. Compliance levels have not improved from 2022 and actions must be taken by suppliers to resolve these issues.
- The number of private group schemes with *E. coli* failures increased from 13 supplies in 2022 to 22 supplies in 2023, impacting approximately 4,600 people.
- •21 PGS supplying 22,000 people failed the standard for Trihalomethanes impacting 14,000 people. (THMs are formed when organic material from the source reacts with chlorine used as disinfection.
- •€38.5 million of government funding that could have been invested in improvements to private supplies between 2019-2023 was not used. The new cycle of the MARWP 2024-2026 was launched in January 2024. Improvements in the application process should make it easier for group water schemes to access funding and deliver improved drinking water quality.

1.4.4 Bathing Season 2024.

2024 saw another busy bathing season for Cork County Council's Water Quality Laboratory. The Council's bathing water programme involves the monitoring of 30 beaches, 11 of which are Blue Flag and 14 are Green Coast, the highest total of flags for any local authority in the country.


Although it was certainly not the warmest summer, it was quite a dry one, which usually bodes well for bathing water quality. And this was indeed the case this year. Of the 155 planned samples taken during this season, only two failed to meet the required the standards, as detailed below.

The Warren: A scheduled sample taken on Monday 15th July failed to meet the standards for *E. Coli* and intestinal enterococci.

Owenahincha: A scheduled sample taken on Monday 12th August failed to meet the standards for *E. Coli*.

In both cases above, a prohibition notice was promptly issued by the laboratory as soon as results came available the following day. A precautionary notice was also issued for the Warren on the same day as Owenahincha, due to information received form Uisce Eireann (pump station outage during overnight storm). These notices were issued in the interests of public health and were done in accordance with protocol and HSE guidelines.

As ever, the laboratory worked intensively to retest the beaches, and in consultation with our HSE colleagues, managed to get the notices lifted before the weekend, all the while keeping our Elected Members, the public and the media informed.





In addition to monitoring water quality, the water quality laboratory acts as the Council's liaison with An Taisce. An Taisce are the governing body for the national Blue Flag and Green Coast programmes. In the 2024 season, An Taisce audited 22 of the Council's 30 monitored beaches. None of the 11 Blue Flag beaches received a major non-compliance, and only two of the 15 Green Coast beaches received a major non-compliance which have since been addressed. Given the large number of beaches and the strict audit criteria, this is an impressive achievement for the Council.

Though not without its challenges, 2024 was another very good year for beaches of County Cork and we look forward to another great season in 2025.

1.5. Community Environmental Awareness Programmes

1.5.1 Cork GAA Community Clean Up Day

In September, the County and City Councils supported Cork GAA in their very first Community Clean-Up Day. The GAA including Cork Camogie and Cork Ladies Gaelic Football Associations were delighted with the overwhelming success of this inaugural event, which saw the association mobilise thousands of club members across the county come together to enhance their local communities. The Council supported the event by supplying litter picking equipment and by facilitating disposal of waste collected at Civic Amenity Sites and at other agreed locations around the county. Municipal District, Area Engineering and Environment Directorate staff were closely involved in planning the delivery of the project. All Civic Amenity Sites across the county remained open later than usual on Saturday 21st to facilitate delivery of the litter collected by GAA volunteers.

Throughout Saturday September 21st, volunteers from all corners of Cork donned gloves, grabbed litter pickers, and set about cleaning up parks, streets, beaches, and public spaces. The event was a true testament to the strength of GAA clubs at a grassroots level, with players, coaches, families, and supporters working side by side to clean up their localities working in tandem with the Tidy Towns Committees, Garda Siochana and local support groups.

Clean-Up Day saw participation from almost 100 GAA clubs, 75 of which are county based, with thousands of volunteers covering many kilometres of streets, parks, and other communal areas. The effort yielded hundreds of bags of litter, ensuring that these spaces are cleaner and more enjoyable for all Cork residents.

With the success of this year's event, Cork GAA has indicated it plans to make Clean-Up Day an annual initiative.

1.5.2 "Take a minute before you bin it." Campaign.

A new awareness campaign by MyWaste.ie 'Take a minute, before you bin it!' aims to increase awareness and knowledge to improve waste segregation. Statistics from the EPA reveals that two-thirds of what ends up in our general waste bins could have been recycled or composted with food waste being the most misplaced item, followed closely by soft plastics.

The message from MyWaste is that whether at home, at work or at play we can all play our part. As Ireland transitions to a more circular economy, this national initiative highlights how simple individual actions, can collectively boost Ireland's recycling rate.

1.5.3 Composting for Schools Programme.

Cork County Council is funding 11 schools across the County to take part in the Composting for School Programme which is delivered by Composting Ireland. The aim of the programme is to help schools set up, start or improve composting in their school to reduce waste, save money and combat climate change. The programme is both environmental and educational.

The Composting for Schools programme is open to Primary and Post Primary schools and is delivered in a hybrid model with 1 in person workshop, 4 online workshops and 2 school visits during the 2024/2025 academic year. Each school also receives a €250 voucher to spend on composting equipment and they have access to a variety of fun and interactive activities for school children to learn about composting.

1.5.4 Climate Literacy Programme.

Cork County Council has once again collaborated with social enterprise 'Education for Sustainability' bringing an eight-week Climate Literacy course to eight additional post primary schools in the county. This is the third time we have offered the course in the county and this year the programme was offered to schools in the Western Division first and then to all schools in the county.

The comprehensive program includes eight visits from a facilitator to train the teacher and provide resources, lesson plans and a digital workbook. Each week, a new topic is explored, covering climate change, sustainable development, climate justice, plastics, fast fashion, sustainable transport, biodiversity, food soil, and taking action. While the course is very suitable for Transition Year or CSPE it can also be integrated with other subjects.

1.5.5 Rubbish Film Festival Videos Update.

As part of Sustainable Development Goals (SDG) week, which took place from 20th - 29th September, the Rubbish Film Festival films from the Cork County winning schools, Schull Community College, Kinsale Community School and De La Salle Macroom, were shown at cinemas across the county (Bantry Cinemax, Clonakilty Park Cinema, Gate Mallow, Gate Midleton and The Regal Cinema Youghal). The promotion began on Friday 13th September and will run for a 4 week period with the videos rotating at every showing.

All of the videos from the Cork County Council schools that participated in the programme were also posted on <u>Cork County Council's Environment Department Facebook</u> page throughout the week.

1.6. National Broadband Plan (NBP)

1.6.1 Digital Connectivity Strategy Update

The July 2024 Digital Connectivity Strategy Update released by DECC reports:

- Commercial Rollout Digital Connectivity
 - > Fibre Rollout
 - eir is in the process of building a FTTP (Fibre To The Premises) network to 1.9 million premises, with over 1.2 million premises passed to date.
 - SIRO recently passed over 600,000 premises with full fibre, and they are on track to reach 700,000 premises by 2026.
 - Virgin Media Ireland is committed to a €200m network upgrade to full fibre, which is continuing to 2025 and will support speeds up to 10Gbps. They have recently reached a milestone of enabling 281,000 premises with full fibre.
 - Commercial Deployment of 5G
 - eir's 5G network rollout continues to expand, offering coverage to over 70% of the population and encompassing more than 600 cities, towns and villages.
 - Vodafone's 5G network is currently live in selected areas across 26 counties in Ireland.
 - Three Ireland's 5G network has 90% population coverage and 5G in every county.
 - In Q1 2024, there were 1,588,631 5G mobile subscriptions.
- National Broadband Ireland Progress National
 - Non-commercial areas
 - The State-led subsidised intervention is being delivered by NBI following the Contract award in 2019. NBI are contracted to roll out a high-speed and future-proofed broadband network across all non-commercial areas in every county and this will cover circa 1.1 million people living and working in over 560,000 premises. This includes almost 100,000 businesses and farms along with some 283 Broadband Connection Points and 672 schools.
 - The process of delivering fibre to all homes in the Intervention Area is progressing with momentum. While NBI is committed to delivering a cumulative target of 185,000 premises by the end of 2023 under the revised Contract targets, NBI passed over 205,600 premises up to the end of December 2023.
 - NBI are now making up for delays encountered due to Covid restrictions and they will continue to seek to accelerate the rollout where possible. They expect to pass over 300,000 premises by the end of 2024.
 - To date over 91,138 full fibre connections have been made by NBI across all counties and demand remains very strong where fibre is available. Over 4,000 connections are being made each month.

1.6.2 National Broadband Ireland- Cork County Progress




Network build is substantially complete in Carrigaline, Midleton, Youghal, Rathmore, Tallow, Templemartin, Kanturk as well as the Hare and Long Island DA's. Deployment in the Abbeyfeale, Clonakilty, Fermoy, Kinsale and Mitchelstown and DA's is ongoing. Survey works are complete in the Bantry, Bere Island, Dursey Island, Eyeries, Horse Island, Kilcrohane, Killavullen, Meelin, Schull and Skibbereen DA's. Survey works are being undertaken in the Cape Clear, Sherkin Island and Grenagh DA's. Survey works are pending at Ballingeary, Carriganimmy, Charleville and Dunmanway DA's

Approx. 77,000 premises across Cork County will ultimately benefit from access to high-speed broadband constructed under the National Broadband. Broadband connections can now be obtained at approx. 30,000 premises in the intervention area and network build at a further 23,000 premises is ongoing.

An overview of the present status and the roll-out across the country is summarised in the 2 graphics below. Whilst the greatest number of fibre deployments to premises have been achieved across county Cork, there remains the greatest number of premises in Cork where deployment is awaited.

1.6.3 Broadband Connection Points

A total of 25 BCP's are now completed across the county and are operational. 23 of these facilities continue to operate as BCP's. Remote working is being accommodated at a number of BCP's.

The Council continues to support the Broadband Connection Points (BCPs) initiative and is co-funding the monthly broadband retail service costs at BCP's in association with Dept. Rural and Community Development. Many of the BCP's availed of Town and Village funding support to purchase furniture and fittings to enhance remote working opportunities.

Centres across the county hosting BCP sites benefited to amounts of €320K following successful applications under the Community Centre Investment Fund grant scheme aimed at upgrading and development of community centre facilities which had become aged and dilapidated over time.

A National Hub Strategy is presently being drafted by Dept. of Rural and Community Development. Broadband Connection Points are being considered as significant pillars in the strategy document as they are considered to have significant value at the level of communities where users might not yet feel ready to engage with the commercial remote working hubs or with the enterprise hub sectors.

Owing to the exit of Inch Community Centre from the BCP initiative, the inclusion of a candidate BCP is being considered at the present. This candidate BCP was a disappointed BCP on the last occasion having narrowly missed out on being included.



1.6.4 Commercial Operator Activity

SIRO report of continuing deployment across the county and of having approximately 30,000 premises passed with fibre and of their intention to pass a further 15,000 premises with fibre by end of 2025. The principal areas where SIRO have been working and the numbers passed in each area include Ballincollig-(430), Bandon-(1,667), Carrigaline-(6,041), Carrigtowhill-(423), Crosshaven-(403), Fermoy-(799), Kanturk-(), Little Island-(6,916), Mallow-(5,349), Midleton-(5,045), Skibbereen-(1,873) and Youghal-(1,816),

Imagine Broadband advise that with the take up of fibre connections to the NBI network that it has become commercially unviable for them to continue providing fixed wireless service in certain regions. As an immediate response, Imagine will be closing fixed wireless broadband network broadcast masts in



Lisgould North on the 30/10/2024 and on Bandon Hill on 09/01/2025. Imagine have been key to providing many rural dwellers with high-speed broadband when wireless broadband was the only option for many households. Imagine are providing helpline services to those who will be affected by the shutdown of their broadcast masts and will assist their customers in providing information on the alternatives now available to them.

Vodafone continue to shut down their 3G network across Cork County. Vodafone advise that this shut down of the 3G network has been successfully undertaken in many other parts of the country. For people with older phones (pre smart phone models) they will seamlessly transfer to the 2G network that will continue to be maintained by Vodafone.

The Vodafone shutdown of the 3G network primarily affects Vodafone customers but it should be noted that Clear Mobile and An Post also use the Vodafone network, so this means that 3G services for Clear Mobile and An Post customers will also be retired. The move by Vodafone is part of a worldwide trend to abandon the 3G network which is considered uneconomic to support. Further information can be obtained on ComReg website at <u>3G Retirement | Commission for Communications Regulation</u> (comreg.ie) and ComReg lists some other devices that may be affected.

The shutdown of 3G networks by other providers is expected to continue.

1.6.5 Gigabit Infrastructure Act (GIA)

The Gigabit Infrastructure Act (GIA) came into force on 11th May last and which will be fully applicable from November 2025, will have very significant implications for all Irish public bodies.

The act will place obligations on local authorities and other public sector bodies to make information on the infrastructure that they own and control, e.g all buildings, ducts, etc, that might be used for the deployment of digital transmission equipment. Public Bodies will be obliged to make information on such infrastructure available to digital operators so that such the infrastructure might be leveraged in achievement of the EU's connectivity targets. The EU's <u>digital decade</u> connectivity target is that of ensuring that by 2030 a fixed gigabit network of a very



high capacity (1 Gbps) will be available to all EU households and that all populated areas will have 5G. Further information can be obtained at <u>Gigabit Infrastructure Act</u> (europa.eu).

1.7. Emergency Services

1.7.1 External Emergency Plan Test-Lilly, Dunderrow.

Lilly have been at their Dunderrow site, near Kinsale, since 1978. The campus includes three high-technology manufacturing platforms – Chemistry, Biology and Peptides – and supplies active ingredient for both clinical trial development and commercial use, making it one of the few such sites in the world. Up to 1900 staff and contractors are employed on campus. The site is considered an Upper-Tier establishment under the COMAH Regulations which requires External Emergency Plans to be tested every three years.

A test of the Lilly External Emergency Plan took place on site on Thursday 18th July 2024. The exercise tested a major accident scenario by simulating an activation of the External Emergency Plan for the site. External Emergency Plans are specific Sub-Plans of the Major Emergency Plan of each Principal Response Agency, including Cork County Council.

The event was well supported by the Interagency Emergency Management Office, Cork County Council, An Garda Siochana, the HSE, the EPA and Lilly Staff.
















NAIP Inspections

The EPA allocated specific minimum farm inspection numbers to each local authority under the <u>National Agricultural Inspection Programme (NAIP) 2024 & 2025</u>. The purpose of the NAIP is to help maintain or bring about an improvement in natural water quality in Ireland. Under the plan Cork County Council has been instructed to undertake initial (first time) Good Agricultural Practice (GAP) inspections on a minimum of 452 farms in 2024 and 586 farms in 2025.

It must be noted that this is the minimum number of first-time inspections in 2024 and 2025, the council has an ongoing programme of follow up engagements and currently plans to undertake over 1,000 farms inspections in total in 2024.






