During this discussion the Members made the following points:

- There are no assurances that this facility will be kept open.
- Same language used before previous closures of other facilities.
- Much needed service in Clonakilty.
- If this service is lost there will be over reliance on the West Cork Rapid Response.
- An extremely worrying situation.
- Primary care is essential.
- Will not be sustainable to centralise this service in Bandon.
- First responders are doing fantastic work.
- Clarity and assurances are needed.

Members agreed to write to the Minister for Health, HSE and South Doc requesting clarity and assurances that this facility will not be closed.
