#### 1.0 TREES

- 1.1 **Tree Type#1 –** Rowan ("Sorbus aucuparia") Sheer water seedling (10m in height x 5m spread on maturity). Tree to be 12/14cm girth, bareroot/root ball to be planted during bareroot season November to March.
- 1.2 **Tree Type#2 –** Wild Cherry ("Prunus avium") 12m in height x 6m spread on maturity. Tree to be 12/14cm girth, bareroot/root ball to be planted during bareroot season November to March.
- 1.3 **Tree Type#3 –** Silver Birch (Betula pendula) 18m in height x 4m spread on maturity. Tree to be 12/14cm girth, bareroot/root ball to be planted during bareroot season November to March.
- 1.4 **Tree Type#4 –** Whitebeam ("Tilla Cordata") 15m in height x 8m spread on maturity. Tree to be 12/14cm girth, bareroot/root ball to be planted during bareroot season November to March.
- 1.5 **Tree Type#5 –** Robin Hill ("Amelanchier x grandiflora") 6m in height x 3m spread on maturity. Tree to be 10/12cm girth, bareroot/root ball to be planted during bareroot season November to March.

#### 2.0 SHRUBS

- 2.1 **Type #A –** Wild Privet ("Ligustrum vulgare") plant bareroot at 30cm intervals during bareroot season Nov March
- 2.2 **Type #B –** Gelder Rose ("Viburnum opulus") plant bareroot during bareroot season Nov March
- 2.3 **Type #C -** Dogwood ("Cornus sanguine") plant bareroot, during bareroot season Nov March

#### 3.0 PLANTING STRATEGY

- 3.1 **Wildflower meadow** by disturbing the soil during construction the natural seed bank will be unearthed and allow naturally occurring wildflowers to grow, additional seeds saved from the surrounding area may be sown.
  - **a)** If the wildflowers that grow are short flowering, the following management will be undertaken:
    - Cut after Dandelions in April, early June, and mid-July if no wildflowers are growing in some areas – cut pathways to allow walkers through the wildflower meadow.
    - No moving in May and moving at 4–6-week intervals.
  - **b)** If the wildflowers are long flowering cut once a year in September, leaving cuttings for a few days for seeds to drop, then gather and remove. Remove tall weeds between March and August.
- 3.2 **Existing Trees** Removal of selected trees will not be done between the 1st of March and the 31st of August to protect biodiversity.
- 3.3 **New trees** and hedging plants will be planted during the bare-root season November to March.

#### 3.4 Northeastern Boundary

- i. Existing sod and stone ditch retain except for section to facilitate pathway.
- ii. Existing mixed hedgerow of Crataegus monogyna (Whitethorn) and Ilex aquifolium (Holly) retain except for section to facilitate pathway. The same species hedging to be planted along the SW boundary.
- iii. As this boundary planting is not the full length of the boundary proposed planting of llex aquifolium to finish the boundary

#### 3.5 **Northwestern Boundary**

- i. Existing wall retain.
- ii. Proposed planting of Escallonia rubra 'Macrantha' (all Ireland Pollinator Plan) on southeast side of this wall in proposed gardens.
- iii. Units 30 to 33 inclusive proposed planting of Amelanchier x grandiflora 'Robin Hill' in each back garden.
- iv. Retain Existing clusters of Salix existing on NE end of this boundary remove in selected area only to open onto proposed apartments building and to allow construction of new pathways.

- v. Retain Existing remaining clusters of hedgerows and trees along this boundary wall to Pairc an Doctuir.
- vi. Proposed planting of 4/5 no. Robin Hill 'Amelanchier x grandiflora trees running parallel to new pathway.

#### 3.6 **Southwestern Boundary**

- i. Existing 3 no. trees retain.
- ii. Additional planting of 3 no. Tillia cordata 'Greenspire' (All Ireland Pollinator Plan) to create tree grouping in southern corner– to replace 2 no. Tillia being removed to facilitate car parking areas.

#### 3.7 **Southeastern Boundary**
