- 1. Can a raised table crossing be installed at the pedestrian crossing on the southern end of the Ashgrove Roundabout, Carrigaline?

- 1. To request that traffic calming measures are introduced on the R611 as you approach the Ashgrove roundabout near the centenary garden. With a particular emphasis on the provision of a raised table at this controlled pedestrian crossing.

- 3. To request a detailed update in relation to TPREP for Carrigaline and what are the next stages.

- 1. Seeking an update on proposed safety measures at Barrett's Bar, Killeady and Ballea Road Junction / waterworks.
- 2. Calling for an investigation and clearing of the gullies and drains in the Lower Road, Ballygarvan (area between the two ramps). During several periods of recent heavy rainfall, there has been flooding on this road with the main gully seemingly unable to take the large amounts of water.

The river through the village needs to be cleared, as well as the piped sections of the river through the village need to be investigated as certain sections are blocked.
