### **1. Community Recognition Fund**

The Community Recognition Fund was first introduced in 2023 to recognise the huge efforts made by communities in welcoming and supporting people coming to Ireland. The Department of Rural and Community Development recently announced funding under Window 2 whereby Bandon Playground has been allocated funding of €55,000. In 2024 significant investment was made from council reserves to remove older wooden equipment and replace it with more durable material and this final proposed investment of €55,000 will ensure the last of the older items are replaced.

### **2. Beach Access Disability works Garretstown and Garrylucas**

As part of the ORIS scheme 2023 Cork County Council were allocated funding of €200,000 for interventions at four beaches in the Western Division with two of them being in the Bandon Kinsale Municipal District. Initial designs have been sought for this and whilst a date has yet to be agreed we hope to commence works in Quarter 4 of this year. Works will include integrating ramps, handrails and level platforms at the base of the ramps.

### **3. Town and Village scheme**

The Town and Village Renewal scheme was launched last week which aims at funding projects that make our towns and villages more attractive and sustainable. The closing date for the submission of applications under the Building and Land Acquisition Measure is 2<sup>nd</sup> May 2025 and for the Main Scheme and Project Development Measure is 25<sup>th</sup> July 2025. Cork County Council will be collating a list of proposals over the coming months for submission to the department by the deadlines outlined

### **4. Development of the Short Quay Kinsale**

Cork County Council previously received funding under the Town Centre First programme for the development of the Short Quay, Kinsale. This is currently being progressed by Cork County Councils placing making unit whereby we aim to have a design completed towards the end of the year. Community engagement will be factored into this process.

### **5. Ballymartle Walk, Riverstick**

This project, which was also funded under ORIS, is currently being progressed by the Riverstick Walking Committee. Both Coillte and Cork County Council have worked closely with them and agreed a specification which is hoped to be delivered by June of this year.

### **6. Cork Community Paint Grant Scheme 2025**

The Relove Paint Community Paint Grant Scheme is now open for applications, continuing a successful three year run in supporting community groups in Cork. This scheme, supporting a circular economy through the recycling of unwanted paint, has attracted widespread participation over recent years. Last year, 96 groups, including Tidy Towns, community associations, sports clubs, and schools from across Cork, received over 2,000 litres of high-quality, upcycled paint. The Community Paint

Grant Scheme is open to community groups, sports clubs and schools who can apply for up to 25 litres of paint, most of which is internal water-based paint, but some external paint may also be available. ### **7. Anti Litter Challenge**

The Anti-Litter Challenge was introduced in the 1990s to tackle the problem of litter in Cork County towns and villages. Communities compete and are scored by judges based on the presence or absence of litter on their roads and streets. The challenge is hugely popular with Tidy Towns groups, community organisations and environmentally conscious volunteers who work tirelessly to keep their communities' litter free.
